
Nature is critical to our economy and our lives.

The National Nature Assessment

SCOPE

Assess the status, observed trends, and future projections of U.S. lands, waters, wildlife, biodiversity and ecosystems and the benefits they provide, including connections to the economy, public health, equity, climate mitigation and adaptation, and national security.

PRINCIPLES

- Authoritative, credible, timely, and concise
- Compliant with relevant laws and policies
- Policy relevant but not policy prescriptive
- Transparent, accurate and reproducible with well-documented methods
- Inclusive
- Use-inspired
- Accessible to the widest possible audience

Subset of Recommendations from Public Comment

- Follow a co-production approach across all assessment phases
- Engage users through trusted networks
- Use a variety of engagement methods
- Honor Indigenous Knowledge and rights
- Reflect lived experiences



Proposed Method Selection & Analysis Phase

Assessment & Bridging Knowledge Approach

- Create multiple roles for Federal and non-Federal contributors to produce the NNA together
- Support all contributors to work together to agree on methods, conduct analyses, and create products.
- Provide guidance and training on respectful collaboration across knowledge systems.
- Ensure free, prior and informed consent for any information gathered from Indigenous Knowledge holders or local communities.
- Engage with the public and Tribal nations beyond the group of contributors, seeking opinions and input on a draft(s) of the National Nature Assessment products.
- Following USGCRP policies and relevant laws, the Federal Steering Committee and USGCRP leadership will retain the authority to make final decisions on the analyses conducted.

Next Steps

 Iterate based on Federal feedback, public comment and Tribal input

 Draft Prospectus, including the assessment approach, this summer
