APPLICABLE REGULATIONS

Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, codified at 2 CFR part 200 amended at 2 CFR part 910, U.S. Department of Energy Financial Assistance Regulation, codified at 10 CFR 605, the Office of Science Financial Assistance Program.

SUMMARY

The Office of Basic Energy Sciences (BES) of the U.S. Department of Energy (DOE) announces its interest in receiving applications in Computational Materials Sciences proposing integrated, multidisciplinary teams that will perform research to develop validated community codes and data bases for predictive design of functional materials, excluding structural materials. Computational Materials Sciences Teams could also involve new approaches to enhance the use of large data sets derived from advanced characterization of materials, materials synthesis, processing, and properties assessments and the parallel data that are generated by large scale computational efforts that model materials phenomena. Computational Materials Sciences will support the Materials Genome Initiative for Global Competitiveness (MGI) that was announced by the President in June 2011. The goal of the MGI is to reduce the time from discovery to deployment of new materials by a factor of two and is tied to advancement of American manufacturing capability.

SUPPLEMENTARY INFORMATION

BACKGROUND

Recent major strides in materials synthesis, processing, and characterization, combined with concurrent advances in computational science - enabled by improvements in high performance computing capabilities - have opened an unprecedented opportunity to design new materials with targeted properties. The opportunity is to leap beyond simple extensions of current theory and models of materials towards a paradigm shift in which specialized computational codes and software, coupled with innovative availability and use of experimental and theoretical data, enable the ability to design, discover, and develop new materials, and in turn, create new advanced, innovative technologies. Given the importance of materials to virtually all technologies, computational materials sciences is a critical area in which the United States needs to be competitive.

If successful, this paradigm shift would significantly accelerate the design of revolutionary materials to meet the Nation's energy goals and enhance economic competitiveness. Development of fundamentally new design principles could enable stand-alone research codes and software packages to address multiple length and time scales for prediction of the total functionality of materials over a lifetime of use. Recent scientific workshops and National Research Council studies have identified enticing scientific challenges that would advance these goals. Examples include dynamics and strongly correlated matter, conversion of solar energy to electricity, design of new catalysts for a wide range of industrial uses, and electron transport in materials for improved electronics. Success will require extensive research and development with the goal of creating and experimentally validating, robust community codes that will enable functional materials innovation.

Research and development to create the computational codes will require a fully integrated team approach, combining the skills of experts in materials theory, modeling, computation, synthesis, characterization, and processing/fabrication. The range of the research will include development of new ab initio theory, advanced materials modeling, mining the data from both experimental and theoretical databases, performing advanced in situ/in operando characterization to generate the specific parameters needed for computational models, and well controlled synthesis to confirm the predictions of the codes. Many of the underlying phenomena require understanding the material dynamics at ultrafast time scales and with near atomic resolution - requiring effective use of the unique world leading tools and instruments at DOE's user facilities, from ultrafast free electron lasers to aberration corrected electron microscopes to the best tools for controlled synthesis.

An ideal end product would be open source, robust, validated, user friendly software (and the associated experimental and computational data) that captures the essential physics and chemistry of relevant systems and can be used by the broader research community and by industry to dramatically accelerate the design of new functional materials. As appropriate, multiple software approaches can be incorporated, for example software that uses the most advanced supercomputers coupled with derivative software for more general, routine use on computer clusters.

SUMMARY CRITERIA

To be considered, an application must address the Eligibility requirements in Section III and the Review Criteria in Section V. In particular, an application should:

- Address a specific class of functional materials, for example one or more of those described in the Computational Materials Science and Chemistry Report or the Mesoscale Science report (see references below). Applications focused on structural materials will not be considered responsive.
- Describe a plan to deliver experimentally validated research codes and the associated experimental and theoretically derived data for the design of functional materials to academia, National Laboratories, and industry. In regards to software developed under this FOA, Applicants must describe how the software will be distributed as open source in an Open Source Software Distribution Plan.
- Use integrated teams combining expertise in materials theory, modeling, computation, synthesis, characterization, and processing/fabrication.
- Articulate a clear management plan which insures a coherent team approach and provides for the maintenance and long-term accessibility of software and data.
- Include a Data Management Plan.
- Include development of software that takes advantage of current and future DOE leadership class computing resources such as those at Argonne National Laboratory, Oak Ridge National Laboratory, and Lawrence Berkeley National Laboratory.
- Provide mechanisms for community input to software and database development.

SECTION II – AWARD INFORMATION

A. TYPE OF AWARD INSTRUMENT

DOE may award a field work authorization, an interagency agreement, or a grant under this Funding Opportunity Announcement. A DOE field work authorization or other appropriate instrument will be awarded to a successful DOE/NNSA National Laboratory contractor. Participation by non-DOE/NNSA Federal agencies and their Federally Funded Research and Development Center (FFRDC) contractors will be funded under an interagency agreement (see Section III. A. ELIGIBLE APPLICANTS). A grant will be awarded to any other successful domestic entity including, but not limited to, universities, nonprofit organizations, and for-profit organizations.

DOE will consider funding multi-institution collaborations under this FOA (see “Team Arrangements” in Section III. D. OTHER ELIGIBILITY REQUIREMENTS).

B. ESTIMATED FUNDING

DOE expects to make multiple Computational Materials Sciences awards for a period of up to four years for each award. Total funding is estimated at a maximum of \$8,000,000 annually across all awards with the potential for additional annual funding in future fiscal years, is expected to be available to support the awards from this FOA, subject to appropriation of funds by Congress. DOE is under no obligation to pay for any costs associated with preparation or submission of applications. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

Funding for all awards and future budget periods are contingent upon the availability of funds appropriated by Congress for the purpose of this program and the availability of future-year budget authority.

C. MAXIMUM AND MINIMUM AWARD SIZE

(See “B. *Estimated Funding*” section above.)

DOE anticipates that individual award sizes will range from \$2,000,000 per year to \$4,000,000 per year. The individual award size will depend on the merit review, the number of meritorious applications, and the availability of appropriated funds.

DOE does not expect to receive applications exceeding the ceiling amounts.

D. EXPECTED NUMBER OF AWARDS

(See “*B. Estimated Funding*” Section above.)

The number of awards will depend on the number of meritorious applications and the availability of appropriated funds. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

E. PERIOD OF PERFORMANCE

Awards are expected to be made for a period of up to four years.

Continuation funding (funding for the second budget year and subsequent budget years) is contingent on: (1) availability of funds appropriated by Congress and future year budget authority; (2) substantial progress towards meeting the objectives of the approved application; (3) submittal and approval of required reports; and (4) compliance with the terms and conditions of the award. Additionally, funding for the final two budget years is contingent upon satisfactory completion of an extensive progress review during the second year of each project, which may include an external peer review. BES will use the mid-term review to assess the productivity and impact of each project and progress toward meeting the stated four-year scientific research goals.

F. TYPE OF APPLICATION

DOE will only accept new applications under this FOA.

G. VALUE/FUNDING FOR DOE/NNSA NATIONAL LABORATORY CONTRACTORS AND NON-DOE/NNSA FFRDC CONTRACTORS

For grant awards, the value of, and funding for, a DOE/NNSA National Laboratory contractor, a non-DOE/NNSA FFRDC contractor, or another Federal agency’s portion of the work will not be included in the award to the successful applicant. DOE will fund a DOE/NNSA National Laboratory contractor through the DOE field work authorization system or other appropriate process and will fund non-DOE/NNSA FFRDC contractors and other Federal agencies through an interagency agreement in accordance with the Economy Act, 31 U.S.C. 1535, or other statutory authority.

H. RESPONSIBILITY

The successful prime applicants/awardees (lead organizations) will be the responsible authority regarding the settlement and satisfaction of all contractual and administrative issues, including but not limited to, disputes and claims arising out of any agreement between the prime applicant and any team member, and/or subawardee.

If a DOE field work authorization or other appropriate instrument is executed with a DOE/NNSA National Laboratory in support of the prime recipient (lead organization), Disputes and Claims will be resolved in accordance with the terms and conditions of the DOE/NNSA National Laboratory's Management and Operating (M&O) contract, as applicable, in consultation with DOE and the prime recipient (lead organization), and in accordance with any terms and conditions between the prime recipient (lead organization) and the DOE/NNSA National Laboratory.

If an award is made to a DOE/NNSA National Laboratory, all Disputes and Claims will be resolved in accordance with the terms and conditions of the DOE/NNSA National Laboratory's M&O contract, as applicable, in consultation between DOE and the prime awardee.

If an award is made to another Federal agency or its FFRDC contractor, all Disputes and Claims will be resolved in accordance with the terms and conditions of the interagency agreement in consultation between DOE and the prime awardee.

SECTION III – ELIGIBILITY INFORMATION

A. ELIGIBLE APPLICANTS

All types of applicants are eligible to apply except nonprofit organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995, and subject to the limitations below:

1. Domestic Organizations

Non-DOE/NNSA FFRDCs and Non-DOE Government Owned Government Operated (GOGOs) Organizations are eligible to apply for funding as a subawardee (team member), but are not eligible to apply as a prime recipient (lead organization).

Federal agencies and instrumentalities (other than DOE) are eligible to apply for funding as a subawardee (team member), but are not eligible to apply as a prime recipient (lead organization).

2. Foreign Organizations

All prime recipients (lead organizations) receiving funding under this FOA must be incorporated (or otherwise formed) under the laws of a State or territory of the United States.

A foreign entity, with or without a subsidiary or affiliate incorporated (or otherwise formed) under the laws of a state or territory of the United States, may receive funding as a subawardee (team member).

3. Incorporated Consortia

Incorporated consortia, which may include domestic and/or foreign entities, are eligible to apply for funding as a prime recipient (lead organization) or subawardee (team member).

Each incorporated consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium must provide a written description of its internal governance structure and its internal rules to the DOE Contracting Officer.

Consortia incorporated in foreign countries are not eligible to apply as a prime recipient (please refer to requirement in “Foreign Organizations” above).

4. Unincorporated Consortia

Unincorporated consortia (team arrangements), which may include domestic and foreign entities, must designate one member of the consortium to serve as the prime recipient/consortium representative (lead organization). The prime recipient/consortium representative must be incorporated (or otherwise formed) under the laws of a State or territory of the United States.

Upon request, unincorporated consortia must provide the DOE Contracting Officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This agreement binds the individual consortium members together and should discuss, among other things, the consortium's:

- Management structure;
- Method of making payments to consortium members;
- Means of ensuring and overseeing members' efforts on the project;
- Provisions for members' cost sharing contributions; and
- Provisions for ownership and rights in intellectual property developed previously or under the agreement.

B. COST SHARING

Cost sharing is not required.

C. ELIGIBLE INDIVIDUALS

Individuals with the skills, knowledge, and resources necessary to carry out the proposed research are invited to develop an application. Individuals from underrepresented groups as well as individuals with disabilities are encouraged to apply.

D. OTHER ELIGIBILITY REQUIREMENTS

Letter of Intent (LOI)

To be considered eligible for an award under this FOA, potential prime applicants (lead organizations) are *required* to submit a LOI in accordance with the instructions provided in Section IV.B.1 of this FOA below. Applications received from an applicant who has not submitted the required LOI will be deemed non-responsive and will be rejected without further review.

The lead organization on an application must be the same as on the required LOI. **If an application is received for which the lead organization has changed since submission of the LOI, then the application will be deemed non-responsive and will be rejected without further review.** The Lead Principal Investigator (PI) or Project Director should not be changed unless unavoidable and only minor edits should be made, if necessary, to the title. If necessary, the applicant may make changes to other senior/key personnel and other participating institutions, although DOE discourages extensive changes.

The Lead Organization and Limitation on Number of Applications

An entity may not submit more than **one** application as the lead organization. If more than one application is received from an entity, DOE will consider only the application that matches a qualified LOI (as described below in Section IV.B.1). The remaining applications will be deemed non-responsive and rejected without further review. However, there is no limitation on the number of applications in which an entity may participate as a team member or subawardee.

The Project Director and Limitation on Number of Applications

The Project Director is the Lead Principal Investigator and must be employed or have an agreement in place to be hired by the lead organization. **An individual may not be named as the Project Director on more than one application.** If the proposed Project Director will not be employed by the lead organization, the application will be deemed non-responsive and will be rejected without further review. Further, if more than one application is received from an applicant identifying the same individual as the Project Director, DOE will consider only the application (if any) that matches a qualified LOI (as described in Section IV.B.1). The remaining applications will be deemed non-responsive and rejected without further review. However, there is no restriction on the number of applications in which an individual may participate as a Principal Investigator (This is not the Lead Principal Investigator/Project Director).

Team Arrangements

Entities proposing as a team must designate a lead organization. LOIs and applications must be submitted on behalf of the team members by the lead organization and DOE will enter into a prime award relationship with the designated lead organization. Only one LOI and one application are to be submitted for each team. The designated lead organization, i.e., the prime applicant, must perform a greater percentage of the effort than any other partner organization or subawardee. The percentage of effort will be determined by reviewing the total budget for each participating organization as a percentage of proposed total project costs. **If an application is received in which the prime applicant is not performing a greater percentage of the effort than each of the other institutional partners, team members, or subawardees, as determined by the budget, the application will be deemed non-responsive and rejected without further review.**

Eligible/Ineligible Entities

If an application is received that includes an ineligible entity, or an employee of an ineligible entity performing activities as a team member and/or subawardee, the application will be deemed non-responsive and rejected without further review. Note, however, that otherwise ineligible entities are not precluded from serving as vendors of materials, supplies, equipment, and providing scientific and technical advisory services to a proposed Team, if they are acting purely in that role. Scientific and technical advisory services allow for the provision of scientific and technical expertise without actually performing research activities; examples of such services include serving as members of advisory committees and technical peer review panels or participation in scientific workshops or conferences.

DOE/NNSA National Laboratory Contractors

DOE/NNSA National Laboratory applicants are eligible to apply for funding as the lead organization or team member under this announcement if their Cognizant DOE/NNSA Contracting Officer provides written authorization. This authorization should be submitted with the application as part of the Budget for DOE/NNSA National Laboratory Contractor File. (This is not required for the National Energy Technology Laboratory since it is a GOGO.) If a DOE/NNSA National Laboratory is selected for award, or proposed as a team member, the proposed work will be authorized under the DOE field work authorization system or other appropriate process and performed under the laboratory's M&O contract, as applicable. The following wording is acceptable for the authorization:

“Authorization is granted for the _____ Laboratory to participate in the proposed project. The work proposed for the laboratory is consistent with or complementary to the missions of the laboratory and will not adversely impact execution of the DOE/NNSA assigned programs at the laboratory.”

Non-DOE/NNSA Federal Agencies and their FFRDC Contractors

Non-DOE/NNSA Federal agencies and their FFRDC contractors are not eligible to be the lead organization under this announcement, but they may be proposed as a team member on another entity's application subject to the following guidelines:

The prime applicant must obtain written authorization for non-DOE/NNSA FFRDC participation. The cognizant Contracting Officer for the Federal agency sponsoring the FFRDC contractor must authorize in writing the participation of the FFRDC contractor on the proposed project and this authorization must be submitted with the application. The written authorization must also contain a determination that the use of a FFRDC contractor is consistent with the contractor's authority under its award and does not place the FFRDC contractor in direct competition with the private sector, in accordance with FAR Part 17.5. The following wording is acceptable for the authorization:

“Authorization is granted for the _____ Laboratory to participate in the proposed project. The work proposed for the laboratory is consistent with or complementary to the missions of the laboratory and will not adversely impact execution of the (insert agency) assigned programs at the laboratory. This laboratory is authorized to perform the work proposed in the application submitted under DOE Funding Opportunity Announcement # DE-FOA-0001276 by the following statutory authority (insert statute name, citation, and section) .”

Performance of Work in the United States

DOE requires all work performed by the prime recipient under funding agreements resulting from this FOA to be performed in the United States except as discussed below: – i.e., a prime recipient must expend its total project costs in the United States.

This requirement does not apply to travel or to equipment, materials and supply purchases. Like all proposed costs, proposed travel, equipment, and material and supply costs will be evaluated to determine whether they are necessary and appropriate for the conduct of the effort. Furthermore, it is the sense of Congress that, to the greatest extent practicable, all equipment and products purchased with funds made available under awards resulting from this FOA should be American-made.

Work funded as a subaward from the prime recipient may be performed outside of the United States.

DATA MANAGEMENT PLAN:

A Data Management Plan as described in Section IV C. “Application Contents and Forms” - Appendix 6, is required. Applications that do not have a Data Management Plan will be deemed nonresponsive and will be not reviewed.

OPEN SOURCE SOFTWARE DISTRIBUTION PLAN:

An Open Source Software Distribution Plan as described in Section IV C. “Application Contents and Forms” - Appendix 7, is required. Applications that do not have an Open Source Software Distribution Plan will be deemed nonresponsive and will be not reviewed.

RESEARCH FOCUS:

Applications must address predictive design of functional materials, excluding structural materials. Applications related to structural materials will not be reviewed.

1. Letter of Intent (LOI)

LETTER OF INTENT DUE DATE

February 23, 2015 at 5:00 PM Eastern Time

A Letter of Intent (LOI) is *required* and must be submitted by 5:00 PM Eastern Time on February 23, 2015. **Any full application received for which there is not an associated LOI will be deemed non-responsive and will be rejected without further review.** In addition, the lead organization on the full application must be the same as on the LOI. If an application is received for which the lead organization has changed since submission of the LOI, then the application will be deemed non-responsive and will be rejected without further review. The Lead PI or Project Director should not be changed unless unavoidable and only minor edits should be made, if necessary, to the title. If necessary, the applicant may make changes to other senior/key personnel and other participating institutions, although DOE discourages extensive changes.

The LOI is to help in planning the review and the selection of potential reviewers for the application. For this purpose, the LOI must include a cover page with the following information:

- Letter of Intent Title (this is the Project Name)
- Lead Principal Investigator Name, Job Title (this is the Project Director)
- Lead Organization
- Lead Principal Investigator Phone Number and Email Address
- Funding Opportunity Announcement Number: DE-FOA-0001276

This cover page must be signed by an official of the lead organization who has the authority to commit institutional support for the application and by the proposed Project Director. For DOE National Laboratory applicants, the institutional official should be the Laboratory Director. For other applicants, this official should be someone who has authority over research activities for

the entire institution, such as the Vice President for Research, Chief Technology Officer, or the equivalent. **All applicants must provide both of these signatures on the LOI.** Applicants that fail to provide both signatures on the LOI will be required to provide a corrected LOI with both signatures on or before March 17, 2015 in order for their full application associated with the LOI to be considered for award.

The cover page must be followed by a clear and concise description of the goals, objectives, and technical approaches of the proposed research. The description of the proposed research may not exceed two pages when printed on 8.5 X 11 inch paper, with a minimum text font size no smaller than Times New Roman 12 point and margins no smaller than one inch on all sides. The required header information and any figures and references, if included, must fit within the two-page limit.

In addition, the LOI must include the following two Tables, which will not count toward the two-page limit for the LOI:

Table 2 should exclude all personnel at any of the institutions listed in Table 1.

- Table 1 and Table 2 will not count in the LOI page limitation.

The Lead Organization and Limitation on Number of Letters of Intent

An entity may not submit more than one LOI as the lead organization. If more than one qualified LOI is received from a lead organization, DOE will consider the first qualified LOI received based on the DOE Office of Science Portfolio Analysis and Management Systems (PAMS) date and time stamp. The remaining LOIs will be deemed non-responsive and the applicant will not be allowed to submit full applications tied to those LOIs. However, there is no limitation on the number of LOIs in which an entity may participate as a team member or subawardee.

The Project Director/Lead Principal Investigator and Limitation on Letters of Intent

The Project Director is the Lead Principal Investigator and must be employed or have an agreement in place to be hired by the lead organization in the event an award is made. An individual may not be named as the Project Director on more than one LOI. If more than one qualified LOI is received from an applicant identifying the same individual as the Project Director, DOE will consider the first qualified LOI received based on the PAMS date and time stamp. The remaining LOIs will be deemed non-responsive and the applicant will not be allowed to submit full applications tied to those LOIs.

All LOIs received by DOE will be acknowledged by an automated email to the Project Director. Any individual named as the Project Director on a LOI that is found to be non-responsive to the LOI requirements will be notified by March 13, 2015, and will be ineligible to submit an application associated with that LOI. LOIs deemed responsive will receive no additional notification.

The LOI must be submitted electronically through the PAMS website:

<https://pamspublic.science.energy.gov/>. It is important that the LOI be a single file with extension .pdf, .docx, or .doc. The Lead PI or Project Director and anyone submitting on behalf of the lead PI must register for an account in PAMS before it will be possible to submit an LOI. All PIs and those submitting LOIs on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

You may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers to access PAMS.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with (“register to”) your institution. Detailed steps are listed below.

Create PAMS Account:

- PAMS will take you to the “Register to Institution” page.
- Type a word or phrase from your institution name in the field labeled, “Institution Name like,” choose the radio button next to the item that best describes your role in the system, and click the “Search” button. A “like” search in PAMS returns results that contain the word or phrase you enter; you do not need to enter the exact name of the institution, but you should enter a word or phrase contained within the institution name. Submit Your Letter of Intent:

- If the Lead PI/PD for whom you are submitting does not appear on the list, it means he or she has not yet registered in PAMS. For your convenience, you may have PAMS send an email invitation to the Lead PI/PD to register in PAMS. To do so, click the “Invite PI” link at the top left of the “Select PI” screen. You can enter an optional personal message to the PI in the “Comments” box, and it will be included in the email sent by PAMS to the Lead PI/PD. You must wait until the Lead PI/PD registers before you can submit the LOI. Save the LOI for later work by clicking the “Save” button at the bottom of the screen. It will be stored in “My Letters of Intent” for later editing.
- Enter a title for your LOI.
- Select the technical contact from the Program Manager dropdown (there will be only one).
- To upload the LOI file into PAMS, click the “Attach File” button at the far right side of the screen. Click the “Browse” (or “Choose File” depending on your browser) button to search for your file. You may enter an optional description of the file you are attaching. Click the “Upload” button to upload the file.
- At the bottom of the screen, click the “Submit to DOE” button to save and submit the LOI to DOE.
- Upon submission, the Lead PI/PD will receive an email from the PAMS system <PAMS.Autoreply@science.doe.gov> acknowledging receipt of the LOI.
- Keep a record of your PAMS LOI tracking number, as you will need this when submitting your application.

You are encouraged to register for an account in PAMS at least a week in advance of the LOI submission deadline to avoid delays with your submission.

The Project Narrative **must not exceed 30 pages** of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard 8.5” by 11” paper with one inch margins (top, bottom, left, and right). The font must not be smaller than Times New Roman 12 point. **Only the first 30 pages of the Project Narrative will be reviewed or considered.** This page limit does not apply to the Cover Page, any Table of Contents (optional, but if included should be limited to one page), Budget Page(s), Budget Justification, biographical material, publications and references, and appendices, each of which may have its own page limit. Headers/footers containing page numbers and project titles/logos may be inserted within the required one inch margins.

Do not include any Internet addresses/Uniform Resource Locators (URLs) that provide supplementary or additional information that constitutes a part of the application. Merit reviewers are not required to access Internet sites; however, Internet publications in a list of references will be treated identically to print publications. See Part VIII.D for instructions on how to mark proprietary application information. To attach a Project Narrative, click “Add Attachment.”

The contents of the Project Narrative are specified in order to ensure that the merit reviewers have the necessary information to conduct proper evaluations. Merit review criteria can be found in Section V. A.2 of this FOA. All Project Narratives must include the following sections:

- Clearly state the four-year scientific research, software development, and data goals;
- Provide an account of any preliminary studies that may be pertinent to the proposed research or any currently available software that will be incorporated;
- State concisely the importance of the research described in the application and its potential scientific impact;
- Include any information that will help to establish the experience and competence of the investigators to pursue the proposed research, including experience in development and management of community software and data resources;
- Discuss the relevant experience of the lead organization, Project Director, and other senior/key personnel in research by teams of investigators.

II. Proposed Research. Applicants must provide detailed information regarding the proposed research. This section should demonstrate the close integration of the proposed research activities aimed at meeting the four year scientific goals and how these will result in capabilities for design and discovery of functional materials. This section, which may be organized in subtasks, must clearly describe the proposed research by including the following:

- Describe a balanced and comprehensive program of basic research that, as needed, supports experimental, theoretical, and computational efforts and the development of new capabilities and approaches in these areas; include a clear statement of the open science questions to be addressed, a detailed research plan, an assessment of the potential scientific impact of the research, and a description of how the research plan will attain the 4-year scientific goals;
- Describe the scientific basis for the software to be developed and how it will be further developed;

- Describe how the software will be experimentally validated and the role of the experimental component of the proposed research;
- Describe how the proposed research will include development of software that will exploit the capabilities of the massively parallel supercomputers;
- Describe how the proposed research embodies the scientific approaches detailed in the following reports: *Computational Materials Science and Chemistry: Accelerating Discovery and Innovation through Simulation-Based Engineering and Science* (<http://science.energy.gov/bes/news-and-resources/reports/abstracts/#CMSC>) and *From Quanta to the Continuum: Opportunities for Mesoscale Science* (<http://science.energy.gov/bes/news-and-resources/reports/abstracts/#OFMS>);

- Describe the role and intellectual contribution of the Project Director, each co-Principal Investigator, and each other senior/key person in the application;
- Briefly outline the resources available including access to existing research space, instrumentation, computational capabilities, and other facilities both within the partner institutions and external to the team (Appendix 4 should include detailed information about facilities, equipment, and capabilities available for the research);
- Describe plans for development and utilization of unique facilities, capabilities or approaches to address the scientific goals;

III. Management Plan. This section must provide a clear, substantive overview of the vision, management, and organization of the proposed Team by including the following:

- Describe the strategy and plan for project operations, the means of achieving an integrated research and development team, and plans for leadership and guidance for the scientific and technical direction of the project;
- Describe how the potential community that will use the software and associated data will be engaged to provide input to the research team;
- Describe how codes and data will be developed, maintained and shared; how will users gain access?
- Define an organizational structure that delineates the roles and responsibilities of senior/key personnel and describes the means of providing internal and external oversight and guidance for scientific and technical direction of the research and software development program, including but not limited to an **advisory committee (required)**, executive committees, program committees, or their equivalent;
- Define proposed management processes for evaluation of research progress, decision making across the team, handling of intellectual property; and intra-team communication;
- Describe the availability of the Project Director, co-principal investigators, and other senior/key personnel, including discussion of their potential involvement in other major projects;
- Include a brief (less than one page) overview of environmental, safety, health, and quality assurance (ES&H and QA) practices and oversight at each participating institution, including any required permits, licenses, and approvals that must be obtained.

Identification of Potential Conflicts of Interest or Bias in Selection of Reviewers: Provide the following information in this section:

- **Collaborators and Co-editors:** List in alphabetical order all persons **outside of the PI’s home institution**, including their current organizational affiliation, who are, or who have been, collaborators or co-authors with the PI on a research project, book or book article, report, or paper during the 48 months preceding the submission of this application. For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group with whom the Principal Investigator interacted on a regular basis while the research was being done. If there are no collaborators to report, state “None.” This information, excluding collaborators from collaborating institutions included in this application, is duplicated in tabular form in Appendix 10.

- Graduate and Postdoctoral Advisors and Advisees: List the names and current organizational affiliations of the PI's graduate advisor(s) and principal postdoctoral sponsor(s). Also, list the names and current organizational affiliations of graduate students and postdoctoral associates that the PI has supervised during the past five years.
- Advisory Committees: List all advisory committees on which the PI serves, including the name of the institution and department.

Personally Identifiable Information (PII): Do not include sensitive personally identifiable information such as a Social Security Number or date of birth.

This document is not included in the three page limit for each biographical sketch.

Individual Commitment Statement: For the Lead Principal Investigator/Project Director, each Principal Investigator, and each additional senior/key person, provide a signed statement that reflects their commitment to this project, including their individual level of time commitment, for a minimum period of four years. Multiple personnel representing the same institution may sign the same letter of commitment, as applicable. Each letter of commitment is limited to one page (this page is not included in the three page limit for each biographical sketch).

- Provide "BIOGRAPHICAL SKETCHES" as Appendix 1 to the Project Narrative within the same file. Do not attach a separate file; and
- This appendix will not count in the Project Narrative page limitation.

After you submit your application through Grants.gov, the application will automatically transfer into the PAMS for processing by the DOE Office of Science. Many functions for grants and cooperative agreements can be done in PAMS, which is available at <https://pamspublic.science.energy.gov>.

You will want to “register to” your application: a process of linking yourself to the application after it has been submitted through Grants.gov and processed by DOE.

You must register in PAMS to submit a pre-application or a Letter of Intent.

You may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers to access PAMS.

Notifications sent from the PAMS system will come from the PAMS email address <PAMS.Autoreply@science.doe.gov>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

6. Viewing Submitted Applications

Each Grants.gov application submitted to the DOE Office of Science (SC) automatically transfers into PAMS and is subsequently assigned to a program manager. At the time of program manager assignment, the three people listed on the SF-424 (R&R) cover page will receive an email with the subject line, “Receipt of Proposal 0000xxxxxx by the DOE Office of Science.” These three people are the Principal Investigator (Block 14), Authorized Representative (Block 19), and Point of Contact (Block 5). In PAMS notation, applications are known as proposals, the Principal Investigator is known as the PI, the Authorized Representative is known as the Sponsored Research Officer/Business Officer/Administrative Officer (SRO/BO/AO), and the Point of Contact is known as the POC.

There will be a period of time between the application's receipt at Grants.gov and its assignment to a DOE Office of Science program manager. Program managers are typically assigned two weeks after applications are due at Grants.gov: Please refrain from attempting to view the proposal in PAMS until you receive an email providing the assignment of a program manager.

Section V – APPLICATION REVIEW INFORMATION

A. CRITERIA

1. Initial Review Criteria

Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 2 CFR 200 as amended by 2 CFR 910, and 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award (including submission of the required LOI); (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied; and **(4) the proposed project is responsive to the objectives of the funding opportunity announcement (note that applications focused on structural materials will be considered non-responsive.**

Applications that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

2. Merit Review Criteria

The application will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, the first five of which will be weighted more heavily than the final two. The first five criteria are of equal value with each other. The final two criteria are of equal value with each other. The questions after each are intended to guide the reviewers; reviewers will not be required to provide written responses to each of these questions.

- Scientific and/or Technical Merit of the Project;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.
- Strength of the Management Plan
- Synergy Among the PIs, including Cohesion and Integration of the Research and Software Development Activities
- Development and Utilization of Unique Facilities, Capabilities or Approaches

SCIENTIFIC AND/OR TECHNICAL MERIT OF THE PROPOSED RESEARCH

- Does the application present a balanced and comprehensive program of basic research that, as needed, supports experimental, theoretical, and computational efforts and development of new capabilities for predictive design of functional materials?
- Does the proposed research embody the scientific approaches detailed in the following reports: *Computational Materials Science and Chemistry: Accelerating Discovery and Innovation through Simulation-Based Engineering and Science* (<http://science.energy.gov/bes/news-and-resources/reports/abstracts/#CMSC>) and *From Quanta to the Continuum: Opportunities for Mesoscale Science* (<http://science.energy.gov/bes/news-and-resources/reports/abstracts/#OFMS>)?

- Does the application contain clearly defined four-year scientific research, data, and software goals?
- Will the research develop software that takes advantage of current and future DOE leadership class computing resources?
- Do the scientific, software, and data goals of the project have sufficient programmatic focus?
- Is the proposed research program likely to meet the stated four-year scientific research, software, and data goals?
- Is the Data Management Plan suitable for the proposed research; to what extent does it make the data available and useful to the scientific community?
- Will the proposed research likely result in useful software and data that will accelerate the design, discovery, and development of new functional materials?

APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- Are the strategy and the plan for the development and operation of the project including the need for an approach involving several senior/key personnel, the means for achieving an integrated Team, and plans for leadership and guidance for the scientific and technical direction, appropriate?
- Does the application present integrated research that embodies the “team science” approach in which the research challenges to be addressed are those that are likely to be overcome only by a centrally managed, multi-disciplinary team?
- Are the proposed scientific methods or approaches detailed in the proposal appropriate to achieve the stated scientific goals?
- Are the plans (if any) for external collaborations and partnerships reasonable and appropriate?
- Are the roles and intellectual contributions of the Project Director, Principal Investigator(s), and all other senior/key personnel adequately described and appropriate?
- Is the proposed approach for making a community code and the associated experimental and computational data available to general users from the research community, including the Open Source Software Distribution Plan, likely to be effective? Is there a plan to get input from the community that will use the data and software?

COMPETENCY OF APPLICANT’S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- Do the applicant’s senior/key personnel have a proven record of research in the disciplines needed for success in this project?
- Do the lead organization, the Director, and the other senior/key personnel have proven records of success in project, program, and personnel management of diverse teams of scientific and technical professionals for projects of comparable complexity and magnitude?
- Is the plan for recruiting any additional scientific and technical personnel including new senior staff, students and postdocs reasonable and appropriate?
- Is the proposed access to existing research space, instrumentation and facilities at the partner institutions likely to meet the needs of the proposed team?

- Is there adequate access to experimental and computational capabilities as needed to ensure successful completion of the proposed research, including access to research capabilities and resources outside of the Team?
- Will the Project Director and senior/key personnel be sufficiently available given their role particularly taking into account their potential involvement in other major projects?
- Does the team have expertise and capabilities required to support the development and maintenance of community research codes and data?

REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the requested operating budget and the distribution of the funds among research tasks/themes, software development and partners reasonable for the program?
- Are the equipment needs adequately identified, and costs for needed new instrumentation or upgrades realistically estimated?
- Are the budgeted costs for preparing space for existing and new equipment and instrumentation appropriate and reasonable?
- Are all subawards, travel, student costs and other ancillary expenses adequately estimated and justified?

STRENGTH OF THE MANAGEMENT PLAN

- Is there a clear lead organization and a qualified Project Director?
- Does the applicant present a comprehensive management plan? What is the likelihood that the applicant can overcome key scientific challenges and shift research directions in response to promising developments? Has the application presented a clearly defined mechanism to evaluate success/failure and to reconfigure research thrusts as needed?
- If needed, is there a well-defined plan to the use of state-of-the-art technology and frequent virtual meetings to enable meaningful, efficient long distance collaboration?
- Does the applicant present an organizational structure that delineates the roles and responsibilities of senior/key personnel and describes the means of providing external oversight and guidance for scientific and technical direction of the research program?
- Is the role of an advisory committee (required) and any executive committee, program committee, or their equivalent adequately described and appropriate?
- Are environment, safety, health and quality assurance (ESH & QA) issues responsibly anticipated and addressed? Does the applicant have a work planning and control process which considers them?

SYNERGY AMONG THE PIs, INCLUDING COHESION AND INTEGRATION OF THE RESEARCH AND SOFTWARE DEVELOPMENT ACTIVITIES

- Does the application describe a well-integrated team based approach to addressing the scientific and software development goals?
- Is the proposed team of researchers likely to work together in a cohesive and integrated manner? Have they demonstrated their ability to do so in the past?
- Have the applicants defined scientific problems that are likely to be addressed only through close collaboration among the researchers on the application?
- Are the elements of the proposed research appropriately integrated, coordinated, and synergistic?

DEVELOPMENT AND UTILIZATION OF UNIQUE FACILITIES, CAPABILITIES OR APPROACHES

- Does the research take advantage of current and future DOE leadership class computing resources?
- Does the proposed research rely on the use of unique facilities at the applicants' home institutions or at US or international user facilities?
- Have the applicants proposed the development of unique facilities, capabilities, or approaches to achieve the stated scientific goals?

B. REVIEW AND SELECTION PROCESS

1. Merit Review

Applications that pass the initial review will be subjected to a formal merit review and will be evaluated based on the criteria described above in Section V.A.2 and as codified at 10 CFR 605.10(d) in accordance with the guidance provided in the "Office of Science Merit Review System for Financial Assistance," which is available at: <http://science.energy.gov/grants/policy-and-guidance/merit-review-system/>.

Following completion of the merit review, a team of Federal officials will review the applications and the evaluations of the Merit Review Panels, summarize the Merit Review Panel members' independent evaluations of the applications submitted, and recommend the application of the program policy factors, as appropriate. The evaluation and selection process may include consideration of any of the program policy factors listed in Section B.2. below. External peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of an application constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

2. Selection

The Selection Official will consider the findings of the Merit Review Panels and the recommendations of Federal officials, as well as the following program policy factors:

- Delineation of the scope of the proposed research from other research activities in which the principal investigators are involved, particularly those supported by DOE and by other federal agencies
- Relevance of the proposed activity to Office of Basic Energy Sciences (BES) priorities
- Ensuring an appropriate balance of activities within BES programs
- Diversity of research activities that will address the scientific grand challenges and use-inspired basic research as articulated in the Basic Energy Sciences Advisory Committee (BESAC) and BES workshop reports
- Relationship of the proposed project to other research and development programs in DOE, including but not limited to the Energy Frontier Research Centers, Energy Innovation Hubs,

and the core research activities within the BES Materials Sciences and Engineering or Chemical Sciences, Geosciences, and Biosciences Divisions

- Potential for developing synergies between the proposed project and other ongoing BES research activities

As part of the selection process, DOE reserves the right to seek clarifications in writing from those applications deemed to have the highest scientific merit in order to facilitate the selection process.

3. Discussions and Award

The Government may enter into discussions with a selected applicant for any reason deemed necessary, including but not limited to the following: (1) Reasonableness and appropriateness of the budget; (2) Possible selection of only portion of the application for award; (3) Request for additional information to determine whether the recipient is capable of complying with the requirements in 2 CFR part 200 as amended by 2 CFR part 910, DOE Financial Assistance Regulation and 10 CFR part 605; and/or (4) The necessity of adding special terms and conditions as a prerequisite for award. Failure to satisfactorily resolve the issues identified by the Government will preclude award to the applicant.

C. ANTICIPATED NOTICE OF SELECTION AND AWARD DATES

DOE anticipates making awards by September 30, 2015, with the possibility of additional awards being made in Fiscal Year 2016, depending on the availability of budget authority and appropriated funds. Applicants selected for award will be notified at least one month before awards may be made.
