## **REGISTRATIONS**

## A. DOE Office of Science Portfolio Analysis and Management System (PAMS)

The Department of Energy (DOE) Office of Science (SC) performs many functions for DOE national laboratory proposals in the Portfolio Analysis and Management System (PAMS), which is available at <u>https://pamspublic.science.energy.gov</u>.

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

To access PAMS, you may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers.

Notifications sent from the PAMS system will come from the PAMS email address <<u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

#### 1. CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website <u>https://pamspublic.science.energy.gov/</u>.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you the "Having Trouble Logging In?" page. (Note: If you reviewed for or were listed as PI on a prior submission to SC but have not previously created an account, you may already be linked to an institution in PAMS. If this is the case, PAMS will take you to the PAMS home page.)

2. REGISTER TO YOUR INSTITUTION:

• Click the link labeled "Option 2: I know my institution and I am here to register to the institution." (Note: If you previously created a PAMS account but did not register to an

institution at that time, you must click the Institutions tab and click the "Register to Institution" link.)

- PAMS will take you to the "Register to Institution" page.
- Type a word or phrase from your institution name in the field labeled, "Institution Name like," choose the radio button next to the item that best describes your role in the system, and click the "Search" button. A "like" search in PAMS returns results that contain the word or phrase you enter; you need not enter the exact name of the institution, but you should enter a word or phrase contained within the institution name. ## SUMMARY

The DOE SC program in Basic Energy Sciences (BES) announces its interest in receiving new proposals in Data Science for Knowledge Discovery for Chemical and Materials Research with the aim of advancing the use of modern data science approaches (artificial intelligence, machine learning, graph theory, uncertainty quantification, etc.) to accelerate discovery in chemical and materials sciences. This funding opportunity is the first in this topical area sponsored by BES.

The program will support efforts (up to \$1,000,000 per year) for research with a focus on applying data science approaches and tools for experimental, theoretical/computational, or synergistic experimental/theoretical/computational research in areas supported by BES. Although the research may involve the development of new data science approaches, the focus of the effort should be on advancing understanding of fundamental properties and processes in chemical and materials systems.

#### SUPPLEMENTARY INFORMATION

## BACKGROUND

Data science combines computer science, applied mathematics, and statistics with domain science to discover new knowledge from often complex (such as unstructured) data sets generated from experimental and/or computational studies. As part of data science, machine learning and artificial intelligence methods are rapidly evolving and leading to more accurate predictions and trustworthy decisions and actions. Thus, these methods are being applied widely in society. While scientific research has benefited greatly in many areas such as the chemical and materials sciences as well as bioinformatics, medicine, drug discovery, systems control, astronomy and particle physics, many opportunities remain for data science to accelerate the rate of fundamental discovery for complex chemical processes and materials. Recent public reports outline some of the emerging opportunities, such as the National Academies report titled Data

Science: Opportunities to Transform Chemical Sciences and Engineering; some of the DOE-BES Basic Research Needs Workshops; the NSF-sponsored report on Framing the Role of Big Data and Modern Data Science in Chemistry; and the multi-agency sponsored report on the Materials Acceleration Platform: Accelerating Advanced Energy Materials Discovery by Integrating High-Throughput Methods with Artificial Intelligence. These reports and other publications conclude that data science is contributing to a new paradigm in scientific research methodology.

Synergistically complementing theory, experimentation, and simulation, data science has already demonstrated some success in accelerating molecular and materials discovery. The next goal for this methodology is to generate new fundamental understanding of physical and chemical behavior, leading to successful predictions well outside the range of the original data, and possibly forcing modifications to the theoretical approaches. One specific area of interest to BES-supported research is that of complex chemical and materials processes, defined as those whose macroscopic properties, reaction mechanisms and dynamic behavior cannot be predicted from a known combination of the properties of the individual components, hence are outside the scope of existing theoretical approaches. Complex systems involve massive combinatorial spaces and nonlinear processes, which are being slowly tackled with large experimental, theoretical and theoretical methods, are expected to accelerate the discovery of fundamentally new chemical mechanisms and material systems with exceptional properties and dynamic behavior, as well as new physical principles or laws. The specific energy-related topics of interest for this FOA, and those excluded, are mentioned below.

## ADDITIONAL REQUIREMENTS

To be considered, a proposal must address the specific Eligibility requirements in Section III and the Review Criteria in Section V. In addition, proposals must:

- Focus on innovative applications of modern data science approaches (artificial intelligence, machine learning, graph theory, uncertainty quantification, etc.) to the research of complex energy-relevant chemical and materials systems to develop new and/or more accurate description of emergent behavior, processes, and mechanisms. A priority outcome from this research should be novel, robust, data-driven, hypothesis-based models that lead to improved understanding. Use of these data models should fill knowledge gaps, correct erroneous predictions based on existing models, extract knowledge from noisy data, and ideally extrapolate beyond the range of the available datasets. Identifying new physical descriptors may be important to manage the complexity of multidimensional datasets and enable inverse or statistically driven design concepts.
- Propose experimental, theoretical/computational, or synergistic experimental/theoretical/computational research that fits within the scope and priorities of core research activities within the BES Chemical Sciences, Geosciences, and Biosciences Division and/or Materials Sciences and Engineering Division. The proposed activity must be aligned with the existing BES portfolio at the National Laboratory leading the proposal. Of special interest is accurate modeling of the mechanisms of chemical and materials processes under exposure to thermal or radiative environments or driven excitations, with the purpose of predicting long-term dynamics.
- Address at least one of the following topics:

- Reaction chemistry across multiple scales in complex environments important in geosciences, catalysis, biochemistry or electrochemistry
- Synthesis science including nucleation, growth and restructuring of hybrid, hierarchical or other complex materials
- Far from equilibrium phenomena where dynamics is fast, such as in transport and separation in complex systems
- Behavior of properties and processes in extreme environments (e.g., radiation, corrosion, stress, pressure, temperature, electric and magnetic fields)
- Discovery of quantum materials and/or their collective, coherent, and strong correlation phenomena

Applicants are referred to relevant Basic Research Needs Workshop reports and the described priority research directions, in particular Quantum Materials, Synthesis Science, Energy and Water, Catalysis Science, and Future Nuclear Energy: https://science.energy.gov/bes/community-resources/reports/.

This lab announcement will NOT consider proposals in certain topics or areas including:

- Quantum computing or quantum systems for quantum information science; energy storage; "omics" data and systems biology approaches; applied research, such as design or optimization of instruments, devices, tools or processes; an exclusive focus on database development and management; studies demonstrating the feasibility or performance of methods as the main or only goal; developments contributing to proprietary products; and research that could be supported by other programs, such as SBIR/STTR.
- Areas covered by the BES Scientific User Facilities Division, such as the development of data science approaches for reduction or analysis of large volumes of data from scientific user facilities as the main goal.
- Streaming data analytics, data management, visualization, and software and computational technologies such as supported by the Office of Advanced Scientific Computing Research and mentioned in the <u>FY 2019 Continuation of Solicitation from the Office of Science</u> (pp. 5-6).

The proposed efforts should integrate the appropriate types of expertise necessary to advance the state-of-the-art in the basic science of the chosen chemical or material challenges as well as in the proposal of data science to pursue those challenges. New data science approaches are expected to accelerate discovery, design, synthesis, characterization, modeling, and simulation for materials science and chemistry.

## **Open Science**

SC is dedicated to promoting the values of openness in Federally-supported scientific research, including, but not limited to, ensuring that research may be reproduced and that the results of Federally-supported research are made available to other researchers. These objectives may be met through any number of mechanisms including, but not limited to, data access plans, data sharing agreements, the use of archives and repositories, and the use of various licensing schemes.

The use of the phrase open-source does not refer to any particular licensing arrangement, but is to be understood as encompassing any arrangement that furthers the objective of openness.

## Collaboration

Collaborative proposals, e.g. submissions of identical proposals by different institutions, will not be accepted. Proposals involving multiple institutions must be submitted by a single lead national laboratory.

## Section II – AWARD INFORMATION

## A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding laboratory work authorizations under this DOE National Laboratory Program Announcement.

DOE will consider funding multi-institution collaborations under this lab announcement. Entities proposing as a team must designate a lead organization. Pre-proposals and proposals must be submitted on behalf of the team members by the lead organization. Only one pre-proposal and one proposal is to be submitted for each team.

Any awards made under this Announcement will be subject to the provisions of the contract between DOE and the awardee National Laboratory.

## **B. ESTIMATED FUNDING**

It is anticipated that up to \$20,000,000 (approximately \$6,667,000 annually for up to 3 years) will be available under this DOE National Laboratory Announcement, contingent on satisfactory peer review and the availability of appropriated funds. Up to 7 awards are expected. Proposers should request project support for three years.

Following the first year award, out-year support will be contingent on the availability of appropriated funds, progress of the research, and programmatic needs. Awards are expected to begin in fiscal year 2019.

DOE is under no obligation to pay for any costs associated with the preparation or submission of a proposal. DOE reserves the right to fund, in whole or in part, any, all, or none of the proposals submitted in response to this DOE National Laboratory Announcement.

## C. MAXIMUM AND MINIMUM AWARD SIZE

The award size will depend on the merit review, the number of meritorious proposals and the availability of appropriated funds.

**Ceiling:** \$1,000,000 per year

**Floor:** \$300,000 per year

## **D. EXPECTED NUMBER OF AWARDS**

The exact number of awards will depend on the number of meritorious proposals and the availability of appropriated funds.

## E. ANTICIPATED AWARD SIZE

The award size will depend on the number of meritorious proposals and the availability of appropriated funds.

## F. PERIOD OF PERFORMANCE

DOE anticipates making authorizations with a project period of three years as befitting the project. Continuation funding (funding for the second and subsequent budget periods) is contingent on: (1) availability of funds appropriated by Congress and future-year budget authority; (2) progress towards meeting the objectives of the approved proposal; (3) submission of required reports; and (4) compliance with the terms and conditions of the award.

## G. TYPE OF PROPOSAL

DOE will only accept new DOE National Laboratory Proposals under this DOE National Laboratory Announcement. Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. SC will request FWPs later from those selected for funding consideration under this Announcement.

## Section III – ELIGIBILITY INFORMATION

## A. ELIGIBLE APPLICANTS AND TOPICS

This is a DOE National Laboratory-only Announcement. FFRDCs from other Federal agencies are not eligible to submit in response to this Program Announcement. A parallel, companion funding opportunity announcement (DE-FOA-0002082) is available for proposals led by other eligible institutions.

## **B. COST SHARING**

Cost sharing is not required.

## **C. ELIGIBLE INDIVIDUALS**

Eligible individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Principal Investigator (PI) are invited to work with their organizations to develop a proposal. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply.

## **D. LIMITATIONS ON SUBMISSIONS**

#### Limitation on Number of Proposals per Laboratory

A national laboratory may not submit more than three pre-proposals or proposals as the lead organization. If more than three proposals or pre-proposals are received from a national laboratory, DOE will consider only those proposals that match a qualified pre-proposal (as described below in Section IV.B.2). The remaining proposals will be declined without further review. However, there is no limitation on the number of proposals in which a national laboratory may participate as a team member or subawardee.

## Lead PI

Proposals with more than one investigator, including proposals with multiple institutions, must designate one and only one investigator as the Lead Principal Investigator, who will exercise overall scientific control and direction of the proposed research. The Lead PI must be employed by or have a written agreement in place to be hired by the applicant institution. If the proposed Lead PI will not be employed by the lead organization at the time of award, the proposal will be declined without further review.

#### Limitation on Number of Proposals per Lead PI

An individual may be the lead PI on no more than one proposal. If more than one proposal is received with the same individual identified as the Lead PI, the last received proposal that matches a qualified pre-proposal (as described in Section IV, Part B.2, below) will be accepted: All other proposals will be declined without review.

Note that there is no limitation on the number of proposals in which an individual may participate in other roles: the limitation is only on serving as the Lead PI on more than one proposal. A Lead PI may serve as a co-investigator on other proposals.

## A. ADDRESS TO REQUEST PROPOSAL PACKAGE

A pre-proposal must be submitted by the date and time listed above. The pre-proposal must be submitted electronically through the DOE SC Portfolio Analysis and Management System (PAMS) website <u>https://pamspublic.science.energy.gov/</u>.

Entities proposing as a team must designate a lead organization. Pre-proposals must be submitted on behalf of the team members by the lead organization. Pre-proposals will be reviewed as outlined below. DOE will send a response by email to each applicant encouraging or discouraging the submission of a proposal by the date shown above. Applicants who have not received a response regarding the status of their pre-proposal by this date are responsible for contacting the program to confirm this status. Only those applicants that receive notification from DOE encouraging a proposal are encouraged to submit a proposal. Other proposals may be declined without review.

Note that a national laboratory can submit only three pre-proposals as the lead organization. If more than three pre-proposals are received that include the required signature from a senior laboratory official, the PAMS timestamp will be used to determine the pre-proposals eligible for further review. Pre-proposals are required.

Note that an individual can serve as the Lead PI on only one pre-proposal. In the event that two or more pre-proposals are received with the same individual as the lead PI, the PAMS timestamp will be used to determine the eligible pre-proposal, and all others will be disqualified.

The pre-proposal attachment must include, at the top of the first page, the following information:

\* A signature of a senior laboratory official who is authorized to commit the Laboratory to perform research is required. This signature on the pre-proposal also indicates that partner institutions have been appropriately engaged in the preparation of the pre-proposal.

Note: All the information above is required. Pre-proposals that are missing any of the above will be considered non-responsive and declined without review.

If a pre-proposal is received in which the lead organization is not performing a greater percentage of the effort than each of the other institutional partners, team members, or subawardees, as determined by the budget, the pre-proposal will be deemed non-responsive and rejected without further review.

This information must be followed by a clear and concise description of the objectives and technical approach of the proposed research, including discussion of how the proposal will meet the requirements of this Announcement. The pre-proposal may not exceed three pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and references, if included, must fit within the three-page limit.

The pre-proposal must describe how the research will advance research described in Section I of this announcement, Supplementary Information. Applicants must describe how the research fits within the scope and priorities of the BES research divisions and are encouraged to review the descriptions of the BES Core Research Activities, which can be found on the BES website at: <a href="https://science.energy.gov/bes/research/">https://science.energy.gov/bes/research/</a>.

The information described below on participating investigators, collaborators, advisors and advisees is required and does not count towards the three-page limit for the preproposal. Failure to include this information will result in the pre-proposal being discouraged from submitting a proposal.

1. On a separate page, the pre-proposal must include a list of the names and institutional affiliations of all participating investigators, including funded collaborators and consultants on the proposed project (one name per line with institutional affiliation, i.e., last name, first

name, institution – no titles are needed).

2. On a separate page(s), for each funded individual, provide a list (one name per line with institutional affiliation, i.e., last name, first name, institution – no titles are needed) of collaborative investigators and co-authors of the past 48 months, co-editors of the past 24 months, past graduate and postdoctoral advisors/advisees, and close associations. **Do not include individuals from the investigators' home institution**, as these individuals would not be asked to review the proposal regardless of their engagement as a collaborator/co-author.

#### PRE-PROPOSAL REVIEW

Federal Program Managers will evaluate all pre-proposal to determine their responsiveness to the requirements of this Announcement and their competitiveness within a scientific topic. The review will be based on the following criteria:

- 1. Responsiveness to the objectives of this Announcement.
- 2. Scientific and technical merit.
- 3. Appropriateness of the proposed research approaches.
- 4. Likelihood of scientific impact.

The review will be conducted by no less than three federal program managers chosen for their topical knowledge and diversity of perspective. Reviews will be comparative for pre-proposals within topical areas with priority given to scientifically innovative and forward-looking basic research with the highest likelihood of success as a proposal, including consideration of BES programmatic priorities. The results of the review will be documented.

Applicants with the highest rated pre-proposals will be encouraged to submit proposals; others will be discouraged from submitting proposals. Upon request, feedback from the comparative review will be provided after the deadline for the receipt of proposals.

SC is committed to ensuring that a sufficient number of applicants will be encouraged to submit proposals to foster a competitive merit review of the proposals. DOE expects to allow approximately 22 proposals, with the exact number based on the review. The intent in discouraging submission of certain proposals is to save the time and effort of applicants in preparing and submitting proposals with a negligible likelihood of success.

The PI will be automatically notified when the pre-proposal is encouraged or discouraged. The DOE SC Portfolio Analysis and Management System (PAMS) will send an email to the PI from <u>PAMS.Autoreply@science.doe.gov</u>, and the status of the pre-proposals will be updated at the PAMS website <u>https://pamspublic.science.energy.gov/</u>. The project summary/abstract must contain a summary of the proposed activity suitable for dissemination to the public. It must be a self-contained document that identifies the name of the applicant, the Lead Principal Investigator (PI), the project title, the objectives of the project, a description of the project, including methods to be employed, the potential impact of the project (i.e., benefits, outcomes). This document must not include any proprietary or sensitive business information as the Department may make it available to the public. The project summary must not exceed 1 page when printed using standard 8.5" by 11" paper with 1" margins (top, bottom, left and right) with font not smaller than 11 point. The one-page project summary/abstract must be placed in a separate, single pdf document and attached on the appropriate screen in PAMS.

The abstract may be used to prepare publicly accessible reports about DOE-supported research.

(\*)A signature of a senior laboratory official who is authorized to commit the Laboratory to perform research is required. This signature on the proposal also indicates that partner institutions have been appropriately engaged in the preparation of the proposal.

The lead applicant/awardee/recipient/organization must be the same as on the required preproposal. **If a proposal is received for which the lead organization has changed since submission of the pre-proposal, then the proposal may be rejected without further review.** The Lead PI should not be changed unless unavoidable (discuss with the program manager) and only minor edits should be made, if necessary, to the title.

The font must not be smaller than 11 point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph. This page limit does not apply to the Cover Page and the associated principal investigator list and budget summary table, Budget Page(s), Budget Justification, biographical material, publications and references, and appendices, each of which may have its own page limit.

Do not include any Internet addresses (URLs) that provide supplementary or additional information that constitutes a part of the proposal. Merit reviewers are not required to access Internet sites; however, Internet publications in a list of references will be treated identically to print publications. See Part VIII.D for instructions on how to mark proprietary proposal information. To attach a Project Narrative, click "Add Attachment."

The Project Narrative comprises the research plan for the project. It should contain enough background material in the Introduction, including review of the relevant literature, to demonstrate sufficient knowledge of the state of the science. The major part of the narrative should be devoted to a description and justification of the proposed project, including details of the method to be used. It should also include a timeline for the major activities of the proposed project, and should indicate which project personnel will be responsible for which activities. There should be no ambiguity about which personnel will perform particular parts of the project,

and the time at which these activities will take place.

**Background/Introduction**: Explanation of the importance and relevance of the proposed work as well as a review of the relevant literature.

**Project Objectives:** This section should provide a clear, concise statement of the specific objectives/aims of the proposed project.

**Proposed Research and Methods**: Identify the hypotheses to be tested and details of the methods to be used.

**Management Plan and Timeline of Activities**: For all proposals, this section should include a timeline for all major research tasks. Note that letters of commitment are required for all funded partner institutions and unfunded collaborators (Appendix 7). For multi-investigator research, this section should also describe the management structure, how effective collaborations among the participants will be fostered, how integration of experimental and theoretical efforts (if both are included in the research) will be attained.

**Project Performance Site(s) [Required for teams involving more than one institution]:** Identify and describe the site(s) where the work will be performed. Work sites at all partner institutions should be briefly described. Appendix 4 should include detailed information about facilities, equipment, and capabilities available for the research. Costs for new construction (including new buildings or additions to existing buildings) will not be allowed in the award.

#### APPENDIX 1: BIOGRAPHICAL SKETCH

Provide a biographical sketch for the Lead PI and other PIs. As part of the sketch, provide information that can be used by reviewers to evaluate the PI's potential for leadership within the scientific community. Examples of information of interest are invited and/or public lectures, awards received, scientific program committees, conference or workshop organization, professional society activities, special international or industrial partnerships, reviewing or editorship activities, or other scientific leadership experiences.

- Provide the biographical sketch information as an appendix to your project narrative.
- Do not attach a separate file.
- The biographical sketch appendix will not count in the project narrative page limitation.
- The biographical information (curriculum vitae) for each person must not exceed 2 pages when printed on 8.5" by 11" paper with 1 inch margins (top, bottom, left, and right) with font not smaller than 11 point. The biographical information (curriculum vitae) must include the following items within its page limit:
  - Education and Training: Undergraduate, graduate and postdoctoral training, provide institution, major/area, degree and year.
  - **Research and Professional Experience**: Beginning with the current position list, in chronological order, professional/academic positions with a brief description.
  - **Publications**: Provide a list of up to 10 publications most closely related to the proposed project. For each publication, identify the names of all authors (in the same

Provide a bibliography of any references cited in the Project Narrative. Each reference must include the names of all authors (in the same sequence in which they appear in the publication),

the article and journal title, book title, volume number, page numbers, and year of publication. For research areas where there are routinely more than ten coauthors of archival publications, you may use an abbreviated style such as the Physical Review Letters (PRL) convention for citations (listing only the first author). For example, your paper may be listed as, "A Really Important New Result," A. Aardvark et. al. (MONGO Collaboration), PRL 999. Include only bibliographic citations. Applicants should be especially careful to follow scholarly practices in providing citations for source materials relied upon when preparing any section of the proposal.

Provide the Bibliography and References Cited information as an appendix to your project narrative.

#### APPENDIX 4: FACILITIES & OTHER RESOURCES

This information is used to assess the capability of the organizational resources, including subawardee resources, available to perform the effort proposed. Identify the facilities to be used (Laboratory, Computer, Office, and Other). If appropriate, indicate their capacities, pertinent capabilities, relative proximity, and extent of availability to the project. Describe only those resources that are directly applicable to the proposed work. Describe other resources available to the project (e.g., machine shop, electronic shop) and the extent to which they would be available to the project. For proposed investigations requiring access to experimental or computational user facilities maintained by institutions other than the applicant, please summarize the plans for accessing these capabilities and past experience with these or similar facilities.

Please provide the Facility and Other Resource information as an appendix to your project narrative.

List major items of equipment already available for this project and, if appropriate identify location and pertinent capabilities. Provide the Equipment information as an appendix to your project narrative.

#### APPENDIX 6: DATA MANAGEMENT PLAN

Provide a Data Management Plan (DMP) that addresses the following requirements:

1. DMPs should describe whether and how data generated in the course of the proposed research will be shared and preserved. If the plan is not to share and/or preserve certain data, then the plan must explain the basis of the decision (for example, cost/benefit considerations, other parameters of feasibility, scientific appropriateness, or limitations discussed in #4). At

a minimum, DMPs must describe how data sharing and preservation will enable validation of results, or how results could be validated if data are not shared or preserved.

- 2. DMPs should provide a plan for making all research data displayed in publications resulting from the proposed research digitally accessible to the public at the time of publication. ## 3. Detailed Instructions for the Budget

Budgets are required for the entire project period. A budget form must be completed for each budget period of the award, and a cumulative budget form for the entire project period will be populated by PAMS. A detailed budget justification narrative must be included after the budget pages. The justification must cover labor, domestic travel, equipment, materials and supplies, and anything else that will be covered with project funds.

All DOE National Laboratories receiving funding as part of the proposed work must be proposed as subawards to the applicant institution. The applicant institution and any other DOE National Laboratory may propose an unlimited number of other subawards. All proposed first-tier subawards (those to be funded by the applicant institution or broken out for separate funding by DOE) must be accompanied by a complete subaward budget in the PAMS website. Second- and third-tier subawards (those to be funded by an institution other than the applicant institution) do not require a complete PAMS subaward budget, but their details must be explained in the budget

justification. Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award; (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied; and (4) the proposed project is responsive to the objectives of the funding opportunity announcement (See Section I, Supplementary Information). In addition to the criteria required by regulation, DOE will apply the following criteria in its initial review of proposals: (5) the proposed project is not duplicative of current programmatic work; (6) for multi-institutional proposals, the lead institution is performing the largest percentage of the effort as determined by the budget allocations (proposals that do not include budget information for all participating institutions will be considered non-responsive); and (7) there is a corresponding, qualified preproposal for the proposal. Proposals that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

Be advised that proposals with a primary focus on advancing data science (e.g., applied mathematics and algorithm development) without application to fundamental science issues under investigation by BES-supported researchers are out of the scope of this Announcement. All proposals must have an encouraged pre-proposal and must be submitted by the same institution that submitted the pre-proposal. All proposals must have a Data Management Plan. Proposals for which the lead institution does not receive the largest percentage of funding compared to partnering institutions will be considered non-responsive.

## 2. Merit Review Criteria

Proposals will be subjected to scientific merit review (peer review). The proposal will be evaluated against the following criteria, with the first four listed in descending order of importance.

- Scientific and/or Technical Merit of the Project;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.

In addition, DOE will ask its merit reviewers to evaluate:

• Adequacy of the Management Plan

Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of a proposal constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

The questions below are provided to the merit reviewers to elaborate the criteria:

SCIENTIFIC AND/OR TECHNICAL MERIT OF THE PROPOSED RESEARCH

- What is the scientific innovation of the proposed research?
- What is the likelihood of achieving valuable and impactful results?
- How does the proposed research advance Data Science related research?
- Is the Data Management Plan suitable for the proposed research?

#### APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- How logical are the hypotheses and how feasible are the research approaches to test these hypotheses?
- How innovative is the proposed method or approach?
- How well does the applicant recognize significant potential problems and consider alternative strategies?

#### COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- What is the past performance and qualifications of the principal investigator (PI) and the broader team of researchers?
- How does the proposed work take advantage of unique facilities and capabilities?

#### REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- How adequate are the proposed budget and staffing levels to carry out the proposed research?
- How reasonable and appropriate is the budget for the scope?

#### MANAGEMENT PLAN

- What are the strengths and weaknesses of the proposal's management plan, including the proposed timeline?
- For multi-investigator research, how will synergy be achieved among the participants, including integration of experimental and theoretical work (if both are included in the proposed research)?

## **B. REVIEW AND SELECTION PROCESS**

#### 1. Merit Review

Proposals that pass the initial review will be subjected to a formal merit review and will be evaluated based on the criteria above.

## 2. Program Policy Factors

The Selection Official may consider any of the following program policy factors in making the selection, listed in no order of significance:

- Availability of funds
- Relevance of the proposed activity to SC-BES priorities (see https://science.energy.gov/bes/csgb/ and https://science.energy.gov/bes/mse/)
- Ensuring an appropriate balance and diversity for activities within SC-BES programs
- Performance under current awards
- Delineation of the scope of the proposed research from other research activities in which the principal investigators are involved, particularly those supported by DOE and by other federal agencies
- Degree of engagement by the lead institution for team proposals

## 3. Selection

The Selection Official will consider the findings of the merit review and may consider any of the Program Policy Factors described above.

## 4. Discussions and Award

The Government may enter into discussions with a selected applicant for any reason deemed necessary. Failure to resolve satisfactorily the issues identified by the Government will preclude award to the applicant.

It is anticipated that the award selection will be completed by September 2019. It is expected that awards will be made in Fiscal Year 2019.
