SUMMARY

The Advanced Scientific Computing Research (ASCR) program of the Office of Science (SC), U.S. Department of Energy (DOE), hereby invites applications for basic mathematical, statistical and computational research that significantly advances uncertainty quantification methodologies for enabling extreme-scale science.

The mission of the DOE Office of Science is the delivery of scientific discoveries, capabilities and major scientific tools to transform the understanding of nature and to advance the energy, economic, and national security of the United States. The next level of scientific discovery will be enabled by research developments that can effectively harness significant or disruptive changes in computing technologies and also build up the requisite mathematical and statistical foundations for confidently using advanced computational approaches to pursue scientific investigations and breakthroughs. Short-range scientific computing agendas look ahead to carrying out DOE-mission research on multi- and many-core, high-performance computing systems. Future extreme-scale scientific computing targets a thousand-fold increase in today's capabilities with only a modest increase in power requirements. Long-range ASCR basic research seeks to anticipate the next paradigm shifts in developing the modeling, simulation, and analysis capabilities for achieving DOE-mission goals using extreme-scale scientific computing in conjunction with theory, experiments, observations, or other relevant resources.

The purpose of this FOA is to invite applications in ASCR Applied Mathematics basic research that significantly advance uncertainty quantification (UQ) methodologies as an enabling technology in extreme-scale scientific computing. UQ broadly refers to the end-to-end study of the accuracy, reliability, development and effective use of computational models in making

scientific inferences. Mathematically rigorous UQ methodologies are essential to a wide range of DOE science and engineering applications in carrying out predictions, design optimization, decision making, or other high-level tasks. UQ relies on a broad range of applied mathematics and statistics research, along with algorithmic and computational developments, and subject matter expertise, to enable an appropriate level of confidence in the use of computational models for scientific investigations.

The computational science and engineering community understands the importance of uncertainty quantification, and key principles, best practices, and tools have been developed and are evolving for predictive science and engineering. At the same time, the nature of high-performance scientific computing research and practice is expected to be fundamentally different given the forecasts for disruptive changes in computing architectures and technologies in this decade. This FOA calls for basic research in methodologies and tools that will deliver significantly improved or advanced UQ capabilities for DOE-mission science based on anticipating the characteristics and challenges, and fully realizing the potential advantages, of using extreme-scale computing systems.

SUPPLEMENTARY INFORMATION

Extreme-scale science research recognizes that fundamentally different techniques, tools, and approaches will likely be needed to reap significant scientific benefits from disruptive, but potentially revolutionary, changes in technology [1,2]. Major advances in science are often closely intertwined with increases in technology capabilities, as typified by "Moore's law" in computing performance. Scientific high-performance computing is a prime example in which needs and expectations for continued exponential scaling in performance are driving, and being influenced by, fundamental changes in underlying technologies such as processors, memory and interconnect systems, and the scientific computing software stack [3].

Over the past two decades, performance improvements were mainly achieved through a combination of: increasing processor speed; bulk-synchronous parallelism - where each programming element executes the same code with regular communication between processors; and advances in applied mathematics in such areas as mathematical modeling, adaptive algorithms and discretization techniques, and numerical analysis. Since 2004, processor speeds have plateaued at about 1-3 gigahertz due to physical limitations in today's materials and fabrication technologies. Fortunately, aside from the performance of hardware component technology, innovations in computational modeling and algorithms for simulations have traditionally outpaced Moore's law in getting more science done per second [4].

Numerous challenges arise in enabling applications to run effectively on next-generation, extreme-scale computing systems. Higher levels of computing performance will require that careful attention is given to the anticipated architectural features, such as:

- Extreme levels of concurrency. Improvements in performance will be achieved only through much higher levels of parallelism.
- Costly data storage and movement, and complex memory hierarchies. On a node, data movement will be much more costly, relative to other operations. Across nodes, networks will provide similar challenges and opportunities.
- Reduced memory sizes per core. The overall cost of memory technology is expected to limit the memory available.
- Resilience and non-deterministic behavior. A high number of hardware faults are expected due to the large number of computing system components.

Additionally, performance portability likely will be more challenging given the technology trends for highly heterogeneous architectures, deep memory hierarchies with reduced memory sizes per core, and other features [1,5,6,7].

UQ methodologies will play a key role in enabling the confident and effective use of extremescale computation as a major scientific tool for the DOE mission. In the context of this FOA, a "UQ methodology" is a generic term that covers a broad range of research topics which, when selectively taken together, form a foundation and significant integrated capability for enabling extreme-scale science. UQ methodology basic research topics includes, but is not limited to: verification and validation; representation of uncertainty and error; sensitivity and uncertainty analysis; multi-scale modeling and simulation; model uncertainty; multi-model ensembles; UQ for inverse problems and model calibration; decision-making and optimization under uncertainty; detection and forecasting of rare events; dealing with high-dimensional probability spaces; statistical modeling and sampling techniques; uncertainty reduction; and other related areas. Given that computational models provide only partial physical understanding, a proposed UQ methodology may also pursue effective strategies for incorporating results from theoretical analysis and/or the use of data from observational or experimental science activities [5,6,7,8,9,10].

The DOE "Scientific Grand Challenges Workshop Series" provides a well-documented set of reports on the grand challenges of specific DOE-mission science domains and the role of extreme-scale scientific computing in addressing those challenges [11,12]. Proposed extreme-scale UQ methodologies will vary across disciplines, along with relevant scientific quantities of interest (QOIs) and the intended use of the computational models. The approach to extreme-scale UQ will also be guided by relevant computational considerations, such as achieving the requisite accuracy and level of confidence in results at some combination of lowest energy and shortest execution time. Computational science is the so-called third pillar of scientific inquiry, beside theory and experimentation, and the rigorous development of extreme-scale UQ methodologies will be essential as an enabling technology for DOE-mission science on future architectures.

Applications submitted in response to this FOA must substantively address the following areas with regard to extreme-scale scientific computing:

- 1. Impact for DOE-mission science: What are the most significant or compelling scientific challenges that are driving the development of the proposed UQ methodology? If successfully developed, how will the advanced UQ capabilities be demonstrated?
- 2. Rigorous UQ methodology: Does the UQ methodology provide a new and/or significant integrated capability for enabling extreme-scale science? What are the potential merits and

limitations of the UQ methodology given the anticipated characteristics and challenges of using extreme-scale computing systems?

3. Advances in applied mathematics and/or statistics basic research: Does the proposed research develop a strong mathematical or statistical foundation for the UQ methodology?

The proposed research is expected to demonstrate the UQ methodology and level of capability through a combination of mathematical or statistical analysis, computational experiments, and a suite of relevant, nontrivial metrics as specified within the submitted FOA application [13].

Collaboration

Collaborative research projects with other institutions such as universities, industry, non- profit organizations, and Federally Funded Research and Development Centers (FFRDCs), including the DOE National Laboratories are strongly encouraged but not required. Collaborative applications submitted from different institutions should clearly indicate they are part of a proposed collaboration. All collaborative applications must use the same title, abstract and technical narrative. In addition, such applications must describe the work and the associated budget for the research effort to be performed under the leadership of the principal investigator in each participating institution. The first page of collaborative applications should contain the project title followed by a tabular list of the researcher names, institutions, annual budget, and role as lead PI or co-PI of each participant. These collaborative applications should all have the same title as the lead institution. Each collaborating institution submitting an application must use the same title in Block 11 of the SF 424 (R&R) form.

Our intent is to create from the various applications associated with a collaborative group one document for merit review that consists of the common, identical application materials combined with a set of detailed budgets from the partner institutions. Thus, it is very important that every application in the collaborative group be exactly identical (including the title) with the exception of the budget and budget justification pages.

Collaborative proposals from DOE National Laboratories should be submitted following the above rules in response to the companion announcement, LAB 13-895.

Section II – AWARD INFORMATION

A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding grants under this FOA.

B. ESTIMATED FUNDING

It is anticipated that up to \$5,000,000 per year will be available under this FOA and DOE National Laboratory Announcement LAB 13-895, contingent on satisfactory peer review and the availability of appropriated funds. Applicants should request project support for up to three years, with out-year support contingent on the availability of appropriated funds, progress of the research, and programmatic needs. Awards are expected to begin in Fiscal Year 2013, which ends on September 30, 2013.

DOE is under no obligation to pay for any costs associated with the preparation or submission of an application. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

C. MAXIMUM AND MINIMUM AWARD SIZE

It is anticipated that approximately 4 to 9 projects will be funded, each with a total project budget ranging from \$150,000 to \$1,400,000 per year. Each institution that participates in a funded project receives a separate award. The minimum and maximum award size to an institution ranges from \$150,000 per year to \$1,400,000 per year.

D. EXPECTED NUMBER OF AWARDS

It is anticipated that approximately 4 to 9 projects will be funded, each with a total project budget ranging from \$150,000 to \$1,400,000 per year. Each institution that participates in a funded project receives a separate award. The number of awards to institutions is expected to range between 5 and 25 (approximately).

E. ANTICIPATED AWARD SIZE

It is anticipated that approximately 4 to 9 projects will be funded, each with a total project budget ranging from \$150,000 to \$1,400,000 per year. Each institution that participates in a funded project receives a separate award. The award size to an institution is anticipated to range between \$150,000 per year to \$1,400,000 per year.

F. PERIOD OF PERFORMANCE

Research Awards are expected to be made for a period of three years. Out-year funding will depend upon suitable progress and the availability of appropriated funds.

G. TYPE OF APPLICATION

DOE will accept only new applications under this FOA.

Section III – ELIGIBILITY INFORMATION

A. ELIGIBLE APPLICANTS

All types of applicants are eligible to apply, except Federally Funded Research and Development Center (FFRDC) Contractors, and nonprofit organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995.

B. COST SHARING

Cost sharing is not required.

C. ELIGIBLE INDIVIDUALS

Individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Program Director/Principal Investigator are invited to work with their organizations to develop an application for assistance. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply for assistance.

A pre-application is required and must be submitted by **5:00 PM Eastern Time, April 24, 2013**. Only the Lead Institution must submit the pre-application. Failure to submit a pre-application will preclude the full application from consideration.

DOE will send a response by email to each applicant encouraging or discouraging the submission of a formal application by April 30, 2013. Applicants who have not received a response regarding the status of their pre-application by this date are responsible for contacting the program to confirm this status. **Only those applicants that receive notification from DOE encouraging a formal application may submit full applications.** No other formal applications will be considered.

Those pre-applications that are encouraged will be used to help the Office of Science begin planning for the formal application peer review process. The intent of the Office of Science in discouraging submission of certain full applications is to save the time and effort of applicants in preparing an application that is unlikely to be selected for award negotiations. Such assessments do not necessarily reflect judgments on the merits of the proposed project.

Pre-applications will be evaluated with respect to the scope and research directions as outlined in the SUMMARY and SUPPLEMENTARY INFORMATION sections. The pre-application may not exceed two pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and references, if included, must fit within the two-page limit.

The pre-application should contain (1) a cover sheet, (2) a technical narrative, and (3) conflict of interest information. The cover sheet identifies the name, institutional affiliation, e-mail address and telephone number of the Lead Principal Investigator and Senior/Key personnel expected to be involved in the project, and an estimated amount of funding requested for each year and for each funded institution. No biographical data need be included.

The technical narrative must provide a clear, concise statement of specific research goals and objectives with respect to the development of UQ methodologies for enabling the confident and effective use of extreme-scale computation as a major scientific tool for the DOE mission.

To help the Office of Science avoid conflicts of interest (COI) in identifying potential reviewers, a list of collaborators, co-editors, and graduate/postdoctoral advisors and advisees must be submitted with the pre-application. These lists should be the final set of pages in the pdf pre-application file and will not count against the two-page limit for the pre-application. A COI list for the Lead Principal Investigator and each project collaborator (supported or unsupported) is required. Further guidance on how to prepare this COI list for each project member is included in the next two paragraphs.

Collaborators and Co-editors: List, in alphabetical order, all persons, including their current organizational affiliations, who are, or who have been, collaborators or co-authors with you on a research project, book or book article, report, abstract, or paper during the 48 months preceding May 2013. For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group for which interactions occurred on a regular basis while the research was being done. Also, list any individuals who are currently or have been in the past coeditors on a special issue with you on a journal, compendium, or conference proceedings during the 24 months preceding May 2013. If there are no collaborators or co-editors to report, state "None."

Graduate and Postdoctoral Advisors and Advisees: List the names of your graduate advisor(s) and principal postdoctoral sponsor(s) and their current organizational affiliations. Also, list the names of your graduate students and postdoctoral associates during the past five years.

It is important that the pre-application (called a preproposal in PAMS) be a single file with extension .pdf, .docx, or .doc. The preproposal must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website <u>https://pamspublic.science.energy.gov/</u>. 1. Initial Review Criteria

Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award; (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied; (4) the proposed project is responsive to the objectives of the funding opportunity announcement, and (5) the proposed project is not duplicative of programmatic work. Applications that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

2. Merit Review Criteria

Applications will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, listed in descending order of importance as found in 10 CFR 605.10 (d), the Office of Science Financial Assistance Program Rule.

- Scientific and/or Technical Merit of the Project;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.

The evaluation process will include program policy factors such as the relevance of the proposed research to the terms of the FOA and the agency's programmatic needs. Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of an application constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

What are the potential merits and limitations of the UQ methodology given the anticipated characteristics and challenges of using extreme-scale computing systems? To what extent does the application identify significant potential problems and consider alternative strategies? How will intermediate results be generated and how will progress be measured?

COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

• To what extent does the project team have the requisite background and level of expertise to accomplish the proposed research? To what extent are the technical responsibilities of senior or key personnel clearly and adequately described? How well organized is the timeline for major research goals and objectives?

REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

• To what extent are the personnel staffing levels adequate to carry out the proposed research? To what extent is the travel budget appropriate and reasonable?

B. REVIEW AND SELECTION PROCESS

1. Merit Review

Applications will be subjected to a formal merit review and will be evaluated based on the criteria codified at 10 CFR 605.10(d) in accordance with the guidance provided in the "Office of Science Merit Review System for Financial Assistance," which is available at: <u>http://www.sc.doe.gov/grants/merit.asp</u>.

2. Selection

The Selection Officials will consider merit review recommendations as well as program policy factors, such as ensuring a programmatically appropriate balance within the program areas, and quality of previous performance. Selection of applications for award will be based upon the findings of the technical evaluations, the importance and relevance of the proposed research to the SC mission, and funding availability.

3. Discussions and Award

The Government may enter into discussions with a selected applicant for any reason deemed necessary, including but not limited to: (1) the budget is not appropriate or reasonable for the requirement; (2) only a portion of the application is selected for award; (3) the Government needs additional information to determine that the recipient is capable of complying with the

requirements in 10 CFR 600 and 10 CFR 605; and/or (4) special terms and conditions are required. Failure to resolve satisfactorily the issues identified by the Government will preclude award to the applicant.
