SUMMARY

The Advanced Scientific Computing Research (ASCR) program of the Office of Science (SC), U.S. Department of Energy (DOE), hereby invites proposals for basic mathematical, statistical and computational research that significantly advances uncertainty quantification methodologies for enabling extreme-scale science.

The mission of the DOE Office of Science is the delivery of scientific discoveries, capabilities and major scientific tools to transform the understanding of nature and to advance the energy, economic, and national security of the United States. The next level of scientific discovery will be enabled by research developments that can effectively harness significant or disruptive changes in computing technologies and also build up the requisite mathematical and statistical foundations for confidently using advanced computational approaches to pursue scientific investigations and breakthroughs. Short-range scientific computing agendas look ahead to carrying out DOE-mission research on multi- and many-core, high-performance computing systems. Future extreme-scale scientific computing targets a thousand-fold increase in today's capabilities with only a modest increase in power requirements. Long-range ASCR basic research seeks to anticipate the next paradigm shifts in developing the modeling, simulation, and analysis capabilities for achieving DOE-mission goals using extreme-scale scientific computing in conjunction with theory, experiments, observations, or other relevant resources.

The purpose of this Program Announcement is to invite proposals in ASCR Applied Mathematics basic research that significantly advance uncertainty quantification (UQ) methodologies as an enabling technology in extreme-scale scientific computing. UQ broadly refers to the end-to-end study of the accuracy, reliability, development and effective use of computational models in making scientific inferences. Mathematically rigorous UQ methodologies are essential to a wide range of DOE science and engineering applications in carrying out predictions, design optimization, decision making, or other high-level tasks. UQ relies on a broad range of applied mathematics and statistics research, along with algorithmic and computational developments, and subject matter expertise, to enable an appropriate level of confidence in the use of computational models for scientific investigations.

The computational science and engineering community understands the importance of uncertainty quantification, and key principles, best practices, and tools have been developed and are evolving for predictive science and engineering. At the same time, the nature of high-performance scientific computing research and practice is expected to be fundamentally different given the forecasts for disruptive changes in computing architectures and technologies in this decade. This Program Announcement calls for basic research in methodologies and tools that will deliver significantly improved or advanced UQ capabilities for DOE-mission science based on anticipating the characteristics and challenges, and fully realizing the potential advantages, of using extreme-scale computing systems.

More specific information is included under SUPPLEMENTARY INFORMATION below.

Proposals must be submitted through a DOE national laboratory. A companion funding opportunity announcement (DE-FOA-0000895) available on Grants.gov describes the Uncertainty Quantification Methodologies for Enabling Extreme-Scale Science funding opportunity for institutions that are not DOE national laboratories. PRE-PROPOSAL DUE DATE: April 24, 2013 at 5:00 PM Eastern Time

Pre-proposals are **REQUIRED** and must be submitted by April 24, 2013, 5:00 PM Eastern Time. Only the Lead Institution must submit the pre-proposal. Failure to submit a pre-proposal will preclude the full proposal from consideration.

DOE will send a response by email to each applicant encouraging or discouraging the submission of a formal proposal by April 30, 2013. Applicants who have not received a response regarding the status of their pre-proposals by this date are responsible for contacting the program to confirm this status. Only those applicants that receive notification from DOE encouraging a formal proposal may submit full proposals. No other formal proposals will be considered.

Those pre-proposals that are encouraged will be used to help the Office of Science begin planning for the formal proposal peer review process. The intent of the Office of Science in discouraging submission of certain full proposals is to save the time and effort of applicants in preparing a proposal that is unlikely to be selected for award negotiations. Such assessments do not necessarily reflect judgments on the merits of the proposed project.

Pre-proposals will be evaluated with respect to the scope and research directions as outlined in the SUMMARY and SUPPLEMENTARY INFORMATION sections. The pre-proposal may not exceed two pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and references, if included, must fit within the two-page limit. The pre-proposal should contain (1) a cover sheet, (2) a technical narrative, and (3) conflict of interest information. The cover sheet identifies the name, institutional affiliation, e-mail address and telephone number of the Lead Principal Investigator and Senior/Key personnel expected to be involved in the project, and an estimated amount of funding requested for each year and for each funded institution. No biographical data need be included.

The technical narrative must provide a clear, concise statement of specific research goals and objectives with respect to the development of UQ methodologies for enabling the confident and effective use of extreme-scale computation as a major scientific tool for the DOE mission.

To help the Office of Science avoid conflicts of interest (COI) in identifying potential reviewers, a list of collaborators, co-editors, and graduate/postdoctoral advisors and advisees must be submitted with the pre-proposal. **These lists should be the final set of pages in the pdf pre-proposal file and will not count against the two-page limit for the pre-proposal**. A COI list for the Lead Principal Investigator and each project collaborator (supported or unsupported) is required. Further guidance on how to prepare this COI list for each project member is included in the next two paragraphs.

Collaborators and Co-editors: List, in alphabetical order, all persons, including their current organizational affiliations, who are, or who have been, collaborators or co-authors with you on a research project, book or book article, report, abstract, or paper during the 48 months preceding May 2013. For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group for which interactions occurred on a regular basis while the research was being done. Also, list any individuals who are currently or have been in the past co-

editors on a special issue with you on a journal, compendium, or conference proceedings during the 24 months preceding May 2013. If there are no collaborators or co-editors to report, state "None.".

Graduate and Postdoctoral Advisors and Advisees: List the names of your graduate advisor(s) and principal postdoctoral sponsor(s) and their current organizational affiliations. Also list the names of your graduate students and postdoctoral associates during the past five years.

It is important that the preproposal be a single file with extension .pdf, .docx, or .doc. The preproposal must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website https://pamspublic.science.energy.gov/. The Principal Investigator and anyone submitting on behalf of the Principal Investigator must register for an account in PAMS before it will be possible to submit a preproposal. All PIs and those submitting preproposalss on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

To access PAMS, you may use Internet Explorer, Firefox, Google Chrome, or Safari browsers. Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

Create PAMS Account: To register, click the "Create New PAMS Account" link on the website https://pamspublic.science.energy.gov/.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you the "Having Trouble Logging In?" page.

Register to Your Institution:

- Click the link labeled "Option 2: I know my institution and I am here to register to the institution." (Note: If you previously created a PAMS account but did not register to an institution at that time, you must click the Institutions tab and click the "Register to Institution" link.)
- PAMS will take you to the "Register to Institution" page.
- Type a word or phrase from your institution name in the field labeled, "Institution Name like," choose the radio button next to the item that best describes your role in the system, and

- click the "Search" button. (Hint: If your institution has an acronym, such as ANL for Argonne National Laboratory or UCLA for the Regents of the University of California, Los Angeles, you may search for the acronym under "Institution Name like." Many institutions with acronyms are listed in PAMS with their acronyms in parentheses after their names.)
- Find your institution in the list that is returned by the search and click the "Actions" link in the Options column next to the institution name to obtain a dropdown list. Select "Add me to this institution" from the dropdown. PAMS will take you to the "Institutions List" page.
- If you do not see your institution in the initial search results, you can search again by clicking the "Cancel" button, clicking the Option 2 link, and repeating the search.

Submit Your Preproposal:

- Create your preproposal outside the system and save it as a file with extension .docx, .doc, or .pdf. Make a note of the location of the file on your computer so you can browse for it later from within PAMS.
- Log into PAMS and click the Proposals tab. Click the "View / Respond to DOE National Laboratory Announcements" link and find the current announcement in the list. Click the "Actions/Views" link in the Options column next to this announcement to obtain a dropdown menu. Select "Submit Preproposal" from the dropdown.
- On the Submit Preproposal page, select the institution from which you are submitting this preproposal from the Institution dropdown. If you are associated with only one institution in the system, there will only be one institution in the dropdown.
- Note that you must select one and only one Principal Investigator (PI) per preproposal; to do so, click the "Select PI" button on the far right side of the screen. Find the appropriate PI from the list of all registered users from your institution returned by PAMS. (Hint: You may have to sort, filter, or search through the list if it has multiple pages.) Click the "Actions" link in the Options column next to the appropriate PI to obtain a dropdown menu. From the dropdown, choose "Select PI."
- If the PI for whom you are submitting does not appear on the list, it means he or she has not yet registered in PAMS. For your convenience, you may have PAMS send an email invitation to the PI to register in PAMS. To do so, click the "Invite PI" link at the top left of the "Select PI" screen. You can enter an optional personal message to the PI in the "Comments" box, and it will be included in the email sent by PAMS to the PI. You must wait until the PI registers before you can submit the preproposal. Save the preproposal for later work by clicking the "Save" button at the bottom of the screen. It will be stored in "My Preproposals" for later editing.
- Enter a title for your preproposal.
- Select the appropriate technical contact from the Program Manager dropdown.
- To upload the preproposal file into PAMS, click the "Attach File" button at the far right side of the screen. Click the "Browse" (or "Choose File" depending on your browser) button to

- search for your file. You may enter an optional description of the file you are attaching. Click the "Attach" button to upload the file.
- At the bottom of the screen, click the "Submit to DOE" button to save and submit the preproposal to DOE.
- Upon submission, the PI will receive an email from the PAMS system acknowledging receipt of the preproposal.

You are encouraged to register for an account in PAMS at least a week in advance of the preproposal submission deadline so that there will be no delays with your submission.

You are encouraged to transmit your proposal well before the deadline. PROPOSALS RECEIVED AFTER THE DEADLINE WILL NOT BE REVIEWED OR CONSIDERED FOR AWARD.

You may enter an optional description of the file you are attaching. Click the "Upload" button to upload the file.
- Once you have saved all of the sections, the "Submit to DOE" option will appear in the dropdown menu at the bottom of the screen.

SUPPLEMENTARY INFORMATION

Extreme-scale science research recognizes that fundamentally different techniques, tools, and approaches will likely be needed to reap significant scientific benefits from disruptive, but potentially revolutionary, changes in technology [1,2]. Major advances in science are often closely intertwined with increases in technology capabilities, as typified by "Moore's law" in computing performance. Scientific high-performance computing is a prime example in which needs and expectations for continued exponential scaling in performance are driving, and being influenced by, fundamental changes in underlying technologies such as processors, memory and interconnect systems, and the scientific computing software stack [3].

Over the past two decades, performance improvements were mainly achieved through a combination of: increasing processor speed; bulk-synchronous parallelism - where each programming element executes the same code with regular communication between processors; and advances in applied mathematics in such areas as mathematical modeling, adaptive algorithms and discretization techniques, and numerical analysis. Since 2004, processor speeds have plateaued at about 1-3 gigahertz due to physical limitations in today's materials and fabrication technologies. Fortunately, aside from the performance of hardware component technology, innovations in computational modeling and algorithms for simulations have traditionally outpaced Moore's law in getting more science done per second [4].

Numerous challenges arise in enabling applications to run effectively on next-generation, extreme-scale computing systems. Higher levels of computing performance will require that careful attention is given to the anticipated architectural features, such as:

- Extreme levels of concurrency. Improvements in performance will be achieved only through much higher levels of parallelism.
- Costly data storage and movement, and complex memory hierarchies. On a node, data movement will be much more costly, relative to other operations. Across nodes, networks will provide similar challenges and opportunities.
- Reduced memory sizes per core. The overall cost of memory technology is expected to limit the memory available.
- Resilience and non-deterministic behavior. A high number of hardware faults are expected due to the large number of computing system components.

Additionally, performance portability likely will be more challenging given the technology trends for highly heterogeneous architectures, deep memory hierarchies with reduced memory sizes per core, and other features [1,5,6,7].

UQ methodologies will play a key role in enabling the confident and effective use of extreme-scale computation as a major scientific tool for the DOE mission. In the context of this Program Announcement, a "UQ methodology" is a generic term that covers a broad range of research topics which, when selectively taken together, form a foundation and significant integrated capability for enabling extreme-scale science. UQ methodology basic research topics includes, but is not limited to: verification and validation; representation of uncertainty and error; sensitivity and uncertainty analysis; multi-scale modeling and simulation; model uncertainty; multi-model ensembles; UQ for inverse problems and model calibration; decision-making and optimization under uncertainty; detection and forecasting of rare events; dealing with high-dimensional probability spaces; statistical modeling and sampling techniques; uncertainty reduction; and other related areas. Given that computational models provide only partial physical understanding, a proposed UQ methodology may also pursue effective strategies for incorporating results from theoretical analysis and/or the use of data from observational or experimental science activities [5,6,7,8,9,10].

The DOE "Scientific Grand Challenges Workshop Series" provides a well-documented set of reports on the grand challenges of specific DOE-mission science domains and the role of extreme-scale scientific computing in addressing those challenges [11,12]. Proposed extreme-scale UQ methodologies will vary across disciplines, along with relevant scientific quantities of interest (QOIs) and the intended use of the computational models. The approach to extreme-scale UQ will also be guided by relevant computational considerations, such as achieving the requisite accuracy and level of confidence in results at some combination of lowest energy and shortest execution time. Computational science is the so-called third pillar of scientific inquiry, beside theory and experimentation, and the rigorous development of extreme-scale UQ methodologies will be essential as an enabling technology for DOE-mission science on future architectures.

Proposals submitted in response to this Program Announcement must substantively address the following areas with regard to extreme-scale scientific computing:

- 1. Impact for DOE-mission science: What are the most significant or compelling scientific challenges that are driving the development of the proposed UQ methodology? If successfully developed, how will the advanced UQ capabilities be demonstrated?
- 2. Rigorous UQ methodology: Does the UQ methodology provide a new and/or significant integrated capability for enabling extreme-scale science? What are the potential merits and limitations of the UQ methodology given the anticipated characteristics and challenges of using extreme-scale computing systems?
- 3. Advances in applied mathematics and/or statistics basic research: Does the proposed research develop a strong mathematical or statistical foundation for the UQ methodology?

The proposed research is expected to demonstrate the UQ methodology and level of capability through a combination of mathematical or statistical analysis, computational experiments, and a suite of relevant, nontrivial metrics as specified within the proposal [13].

Collaboration

Collaborative research projects with other institutions such as universities, industry, non-profit organizations, and Federally Funded Research and Development Centers (FFRDCs), including the DOE National Laboratories are strongly encouraged but not required. Collaborative proposals submitted from different institutions should clearly indicate they are part of a proposed collaboration. PROJECT NARRATIVE (NO MORE THAN 15 PAGES LONG)

The project narrative must not exceed 15 pages of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard 8.5" by 11" paper with 1 inch margins (top, bottom, left, and right). The font must not be smaller than 11 point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph. Proposals exceeding the page limit will be rejected without review.

Do not include any Internet addresses (URLs) that provide supplementary or additional information that constitutes a part of the proposal. Using Internet sites in an attempt to avoid page limits will fail: the content of those sites will not be reviewed. References posted to an Internet-based archive or publications are permitted in a list of references. To attach a Project Narrative, click "Add Attachment."

Background/Introduction: Explanation of the importance and relevance of the proposed work as well as a review of the relevant literature.

For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group with whom the Principal Investigator interacted on a regular basis while the research was being done. Also, list any individuals who are currently, or have been, co-editors with you on a special issue of a journal, compendium, or conference proceedings during the 24 months preceding the submission of this proposal. If there are no collaborators or co-editors to report, state "None."

Information not easily accessible to a reviewer may be included in this appendix, but do not use this appendix to circumvent the page limitations of the proposal. Reviewers are not required to consider information in an appendix, and reviewers may not have time to read extensive appendix materials with the same care they would use with the proposal proper.

- This appendix will not count in the project narrative page limitation.

Detailed Instructions for the Budget

Budgets are required for the entire project period. A budget form should be completed for each budget period of the award, and a cumulative budget form for the entire project period will be populated by PAMS. A detailed budget justification narrative should be included after the budget pages. The justification should cover labor, domestic travel, equipment, materials and supplies, and anything else that will be covered with project funds.
