REGISTRATIONS

A. DOE Office of Science Portfolio Analysis and Management System (PAMS)

The DOE Office of Science performs many functions for DOE national laboratory proposals in the Portfolio Analysis and Management System (PAMS), which is available at https://pamspublic.science.energy.gov.

There are many activities that you can perform in PAMS, and more functionality will be added throughout the near future. DOE national laboratories will submit pre-proposals, letters of intent, and proposals directly into PAMS.

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

To access PAMS, you may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers.

Notifications sent from the PAMS system will come from the PAMS email address < <u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

1. CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website https://pamspublic.science.energy.gov/.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you the "Having Trouble Logging In?" page. (Note: If you reviewed for or were listed as PI on a prior submission to the Office of Science but have not previously created an account, you may already be linked to an institution in PAMS. If this is the case, PAMS will take you to the PAMS home page.)

2. REGISTER TO YOUR INSTITUTION:

- Click the link labeled "Option 2: I know my institution and I am here to register to the institution." (Note: If you previously created a PAMS account but did not register to an institution at that time, you must click the Institutions tab and click the "Register to Institution" link.)
- PAMS will take you to the "Register to Institution" page.
- Type a word or phrase from your institution name in the field labeled, "Institution Name like," choose the radio button next to the item that best describes your role in the system, and click the "Search" button. A "like" search in PAMS returns results that contain the word or phrase you enter; you need not enter the exact name of the institution, but you should enter a word or phrase contained within the institution name. (Hint: If your institution has an acronym, such as ANL for Argonne National Laboratory or UCLA for the Regents of the University of California, Los Angeles, you may search for the acronym under "Institution Name like." Many institutions with acronyms are listed in PAMS with their acronyms in parentheses after their names.)
- Find your institution in the list that is returned by the search and click the "Actions" link in the Options column next to the institution name to obtain a dropdown list. Select "Add me to this institution" from the dropdown. PAMS will take you to the "Institutions List" page.

SUMMARY

The Advanced Scientific Computing Research (ASCR) program of the Office of Science (SC), U.S. Department of Energy (DOE), hereby invites proposals with the potential to enable significant research and computational advances for extreme-scale science.

The mission of the DOE Office of Science is the delivery of scientific discoveries, capabilities and major scientific tools to transform the understanding of nature and to advance the energy, economic, and national security of the United States. Extreme-scale science research recognizes that fundamentally different techniques, software tools, and approaches will likely be needed to reap scientific benefits from disruptive, but potentially revolutionary, changes in technology. Major changes are occurring not only in scientific computing technologies (e.g., processors, memory and interconnect systems), but also in sensors and other hardware technologies at DOE experimental scientific user facilities. The purpose of this Program Announcement is to invite exploratory basic research proposals with the potential to deliver significantly advanced or improved science capabilities in light of emerging and disruptive technology changes.

More specific information is included under SUPPLEMENTARY INFORMATION below.

Proposals must be submitted through a DOE National Laboratory. A companion funding opportunity announcement (DE-FOA-0001003) available on Grants.gov describes the funding opportunity for institutions that are not DOE national Laboratories. Consult DE-FOA-0001003 for information on eligibility for that announcement.

SUPPLEMENTARY INFORMATION

The mission of the Advanced Scientific Computing Research (ASCR) program is to advance applied mathematics and computer science; deliver, in partnership with disciplinary science, the most advanced computational scientific applications; advance computing and networking capabilities; and develop, in partnership with U.S. industry, future generations of computing hardware and tools for science. A major objective of the ASCR basic research portfolio is to enable DOE-mission science applications to take full advantage of next-generation, high-performance computing systems. Desired outcomes include advances in scalable algorithms, programming models, operating systems, and enabling technologies that will make massively parallel, heterogeneous computer architectures more efficient and practical to use in carrying out

scientific research activities. A complementary ASCR objective is to build up the computational research infrastructure for enabling data-intensive science advances. Taken together and in the spirit of harnessing emerging and leading-edge technologies for scientific discovery, these two objectives fall under the umbrella of extreme-scale science research.

This Exploratory Research for Extreme-Scale Science (EXPRESS) Program Announcement is an initial effort for stimulating early investigations of potentially high-impact approaches for extreme-scale science research across ASCR basic research subprograms. EXPRESS focuses on topic areas related to exascale computing or data-intensive science. A recent ASCR Advisory Committee (ASCAC) report describes research goals for exascale computing and data-intensive science, and identifies investments that are most likely to positively impact both areas [A1]. To complement the ASCAC report's 10-year outlook, we seek to initiate an ASCR extreme-scale science research portfolio comprised of small-award projects funded over a short period of time (two years) – see the section on Award Information for complete details. The objective is to provide seed funding to explore potentially fruitful areas of high-impact research, with results that can inform ASCR as it executes an extreme-scale science research agenda. See [A2-A5], for additional reports on challenges and opportunities related to DOE science and technology advances.

EXPRESS is not intended to incrementally extend current research in the area of the proposed project. The exploratory nature of the proposed research should reflect substantially different scientific directions from those already being pursued in the investigator's research or elsewhere. While the research direction may have its foundation in the investigator's prior work and expertise, it cannot be an obvious extension or scale up of a current research enterprise which could be anticipated to be competitive as a new or renewal project. Rather, the proposed project must reflect fundamentally new strategies toward the potential solution of a challenging problem in extreme-scale science research. It is expected that the proposed project will derive and significantly benefit from the exploration of innovative ideas and/or from the development of unconventional approaches. Proposals for more broadly focused research, larger award sizes, or longer periods of performance (more than two years) should be submitted to other Program Announcements.

Applied Mathematics

The Applied Mathematics subprogram supports basic research leading to fundamental mathematical advances and computational breakthroughs across DOE and Office of Science missions. For this subprogram, the investigator should state how the proposed applied mathematics research may have a significant impact to scientific computing at the extreme scale and is relevant to ASCR's exascale computing goals. For references, please see [A1-A5, B1-B3].

Research focused on any of the following will be considered out of scope: (1) tailoring or implementation of existing numerical methods for specific scientific problems; (2) HPC implementation or "framework" for scientific or engineering calculations that are based on specific programming models (for example, "OpenCL", "CUDA") or architectures (such as "GPGPU", "MIC", or variants); or (3) solutions for specific scientific or engineering problems that are not applicable to a broader class of problems.

Computer Science

The Computer Science subprogram supports research to enable computing at extreme scales and the understanding of extreme scale data from simulations, experiments and observations. A fundamental challenge for researchers is in enabling science applications to take advantage of computer systems with increasing scale and complexity arising from the use of technology advances such as multicore chips and specialized accelerator processors. Significant innovation in computer science is needed to realize the potential of next generation high performance computing systems and to address the data management, storage and analysis challenges emerging at scientific user facilities. For this subprogram, the investigator should state how the proposed computer science research may have a significant impact to scientific computing at the extreme scale and is relevant to ASCR's exascale computing goals. For references, please see [A1-A5, C1-C10].

Topics that are out of scope include hardware architecture, all aspects of quantum computing, networking, computer-supported collaboration, social computing, natural language processing / understanding / generation and/or analysis, generalized research in human-computer interaction, discipline-specific data analytics and informatics, research focused on the World Wide Web and/or Internet, and research that is only applicable to hand-held, portable, desktop, embedded or cloud computing.

Next Generation Networking for Science

The Next Generation Networking for Science subprogram conducts research and development activities to support high-end science in the Office of Science and facilitate scientific collaborations. The ASCR Extreme-Scale Science reports [A1-A5, D4] provide roadmaps on the development efforts needed to create and productively use an operational exascale class computer. For this subprogram, ASCR would benefit from detailed design studies that provide roadmaps for the development of other infrastructure elements (e.g., personal to mid-range computers, storage systems, analytical and visualization engines, unique science instruments, and networks) of this extreme-scale science ecosystem [D1-D3].

Collaboration

Collaborative research projects with other institutions such as universities, industry, non-profit organizations, and Federally Funded Research and Development Centers (FFRDCs), including the DOE National Laboratories are strongly encouraged but not required. Collaborative proposals submitted from different institutions should clearly indicate they are part of a proposed collaboration. All collaborative proposals must use the same title, abstract and technical narrative. In addition, such proposals must describe the work and the associated budget for the research effort to be performed under the leadership of the principal investigator in each participating institution. The first page of collaborative proposals should contain the project title followed by a tabular list of the researcher names, institutions, annual budget, and role as lead PI or co-PI of each participant. These collaborative proposals should all have the same title as the lead institution. Each collaborating institution submitting a proposal must use the same title.

Our intent is to create from the various proposals associated with a collaborative group one document for merit review that consists of the common, identical proposal materials combined with a set of detailed budgets from the partner institutions. Thus, it is very important that every proposal in the collaborative group be identical (including the title) with the exception of the budget and budget justification pages.

Collaborative proposals from institutions other than DOE National Laboratories should be submitted following the above rules in response to the companion announcement, DE-FOA-0001003.

Section II – AWARD INFORMATION

A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding laboratory work authorizations under this DOE National Laboratory Program Announcement.

B. ESTIMATED FUNDING

It is anticipated that up to \$2,000,000 per year will be available under this Program Announcement and the funding opportunity announcement DE-FOA-0001003, contingent on satisfactory peer review and the availability of appropriate funds. Applicants should request project support for two years, with out-year support contingent on the availability of appropriated funds, progress of the research, and programmatic needs. Awards are expected to begin in Fiscal Year 2014, which ends on September 30, 2014.

DOE is under no obligation to pay for any costs associated with preparation or submission of proposals. DOE reserves the right to fund, in whole or in part, any, all, or none of the proposals submitted in response to this DOE National Laboratory Program Announcement.

C. MAXIMUM AND MINIMUM AWARD SIZE

Under this Program Announcement, it is anticipated that each funded project will have a total budget of \$250,000 per year for two years. Each institution that participates in a funded project receives a separate award. The award size to an institution is expected to be less than or equal to \$250,000 per year for two years. Applicants are strongly advised to propose total project research budgets as close as possible to \$250,000 per year for two years.

The award size will depend on the number of meritorious proposals and the availability of appropriated funds.

D. EXPECTED NUMBER OF AWARDS

Under this Program Announcement, it is anticipated that each funded project will have a total budget of \$250,000 per year for two years. Each institution that participates in a funded project receives a separate award. The number of awards to institutions is expected to range between 5 and 25 (approximately).

E. ANTICIPATED AWARD SIZE

Under this Program Announcement, it is anticipated that each funded project will have a total budget of \$250,000 per year for two years. Each institution that participates in a funded project receives a separate award. The award size to an institution is expected to be less than or equal to \$250,000 per year for two years.

The award size will depend on the number of meritorious proposals and the availability of appropriated funds.

F. PERIOD OF PERFORMANCE

DOE anticipates making awards with a project period of two years.

G. TYPE OF PROPOSAL

DOE will accept new DOE National Laboratory Proposals under this DOE National Laboratory Program Announcement. Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. The Office of Science will request FWPs later from those selected for funding consideration under this Announcement.

Section III – ELIGIBILITY INFORMATION

A. ELIGIBLE APPLICANTS AND TOPICS

This is a DOE Lab-only Announcement. FFRDCs from other Federal agencies are not eligible to submit in response to this Program Announcement.

B. COST SHARING

Cost sharing is not required.

C. ELIGIBLE INDIVIDUALS

Eligible individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Principal Investigator are invited to work with their organizations to develop a proposal. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply.

A pre-proposal is required and must be submitted by December 3, 2013 at 5 PM Eastern Time. Only the Lead Institution must submit the pre-proposal. The pre-proposal must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website https://pamspublic.science.energy.gov/. Failure to submit a pre-proposal will preclude the full proposal from consideration.

Pre-proposals will be reviewed and DOE will send a reply by e-mail to each applicant encouraging or discouraging the submission of a full proposal. A discouragement decision does not necessarily reflect judgment on the scientific or technical merits of the proposed project and it seeks to avoid the preparation of a proposal that is not likely to be selected for award negotiations. Applicants who have not received a response regarding the status of their preproposals by December 16, 2013 are responsible for contacting the program to confirm this status. Only those applicants that receive notification from DOE encouraging a full proposal may do so. No other full proposals will be considered.

Pre-proposals will be evaluated with respect to the scope and research areas as outlined in the SUMMARY and SUPPLEMENTARY INFORMATION sections. The pre-proposal should contain (1) a one-page cover sheet, (2) a two-page technical narrative, and (3) conflict of interest information.

The one-page cover sheet identifies the name, institutional affiliation, e-mail address and telephone number of the Lead Principal Investigator and Senior/Key personnel expected to be involved in the project, and an estimated amount of funding requested for each year and for each funded institution. No biographical data need be included.

The technical narrative may not exceed two pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and reference, if included, must fit within the two-page limit. The technical narrative must provide a clear and concise description of the objectives and technical approach of the proposed research.

To help the Office of Science avoid conflicts of interest (COI) in identifying potential reviewers, a list of collaborators, co-editors, and graduate/postdoctoral advisors and advisees must be submitted with the pre-proposal. **These lists should be the final set of pages in the pdf for the pre-proposal.** A COI list for the Lead Principal Investigator and each project collaborator (supported or unsupported) is required. For each project participant, provide a list of collaborative co-investigators including co-authors of the past 48 months, co-editors of the past 24 months, graduate and postdoctoral advisors/advisees.

Those pre-proposals that are encouraged will be used to help the Office of Science begin planning for the full proposal peer review process. The intent of the Office of Science in discouraging submission of certain full proposals is to save the time and effort of applicants in preparing and submitting full proposals not responsive to this Program Announcement.

The Principal Investigator will be automatically notified when the pre-proposal is encouraged or discouraged. The DOE Office of Science Portfolio Analysis and Management System (PAMS) will send an email to the Principal Investigator from PAMS.Autoreply@science.doe.gov, and the status of the pre-proposal will be updated at the PAMS website https://pamspublic.science.energy.gov/. Notifications are sent as soon as the decisions to encourage or discourage are finalized.

It is important that the pre-proposal be a single file with extension .pdf, .docx, or .doc. The pre-proposal must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website https://pamspublic.science.energy.gov/. The Principal Investigator and anyone submitting on behalf of the Principal Investigator must register for an account in PAMS before it will be possible to submit a pre-proposal. All PIs and those submitting pre-proposals on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

To access PAMS, you may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers.

- Upon submission, the PI will receive an email from the PAMS system < PAMS.Autoreply@science.doe.gov > acknowledging receipt of the pre-proposal.

You are encouraged to register for an account in PAMS at least a week in advance of the preproposal submission deadline so that there will be no delays with your submission.

COVER PAGE SUPPLEMENT FOR COLLABORATIONS

Collaborative proposals submitted from different institutions must clearly indicate they are part of a collaborative project/group. Every partner institution must submit a proposal through its own sponsored research office. Each proposal within the collaborative group, including the narrative and all required appendices and attachments, must be identical with one exception: The exception is that each proposal must contain unique budget and budget justification documents corresponding to the expenditures for that proposal's submitting institution only. Each collaborative group can have only one lead institution. The common narrative must identify the lead institution and must contain a summary table describing the budget breakdown by institution for all participants.

The Office of Science will use the multiple proposals associated with a collaborative group to create one consolidated document for merit review that consists of the common, identical proposal materials combined with a set of detailed budgets from the partner institutions. It is very important that every proposal in the collaborative group be identical (including the title) with the exception of the budget and budget justification pages.

If the project is a collaboration, provide the following information on a separate page as a supplement to the cover page.

- Indicate the lead PI who will be the point of contact and coordinator for the combined research activity.
- List all collaborating institutions by name with each institution's investigator on the same line

PROJECT NARRATIVE (NO MORE THAN 10 PAGES LONG)

The project narrative **must not exceed 10 pages** of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard 8.5" by 11" paper with 1 inch margins (top, bottom, left, and right). The font must not be smaller than 11 point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph.

The Project Narrative comprises the research plan for the project. It should contain enough background material in the Introduction, including review of the relevant literature, to demonstrate sufficient knowledge of the state of the science. The narrative should provide a clear, concise statement of the specific objectives/aims of the proposed project. The major part of the narrative should be devoted to a description and justification of the proposed project, including details of the methods to be used. It should also include a timeline for the major activities of the proposed project.

Do not include any Internet addresses (URLs) that provide supplementary or additional information that constitutes a part of the proposal. Using Internet sites in an attempt to avoid page limits will fail: The content of those sites will not be reviewed. See Part VIII.D for instructions on how to mark proprietary proposal information.

APPENDIX 1: BIOGRAPHICAL SKETCH

Provide a biographical sketch for the Principal Investigator (PI) as an appendix to your technical narrative. As part of the sketch, provide information that can be used by reviewers to evaluate the PI's potential for leadership within the scientific community. Examples of information of interest are invited and/or public lectures, awards received, scientific program committees, conference or workshop organization, professional society activities, special international or industrial partnerships, reviewing or editorship activities, or other scientific leadership experiences. The biographical information (curriculum vitae) must not exceed 3 pages when printed on 8.5" by 11" paper with 1 inch margins (top, bottom, left, and right) with font not smaller than 11 point and must include the following:

Education and Training: Undergraduate, graduate and postdoctoral training, provide institution, major/area, degree and year.

Research and Professional Experience: Beginning with the current position list, in chronological order, professional/academic positions with a brief description.

Publications: Provide a list of up to 10 publications most closely related to the proposed project. For each publication, identify the names of all authors (in the same sequence in which they appear in the publication), the article title, book or journal title, volume number, page numbers, year of publication, and website address if available electronically. Patents, copyrights and software systems developed may be provided in addition to or substituted for publications. An abbreviated style such as the Physical Review Letters (PRL) convention for citations (list only the first author) may be used for publications with more than 10 authors.

Synergistic Activities: List professional and scholarly activities related to the effort proposed. Some examples might be invited and/or public lectures, awards received, scientific program committees, conference or workshop organization, professional society membership and/or activities, special international or industrial partnerships, reviewing or editorship activities, or other scientific leadership experiences.

Collaborators and Co-editors: List in alphabetical order all persons, including their current organizational affiliation, who are, or who have been, collaborators or co-authors with you on a research project, book or book article, report, abstract, or paper during the 48 months preceding the submission of this proposal. For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group with whom the Principal Investigator interacted on a regular basis while the research was being done. Also, list any individuals who are currently, or have been, co-editors with you on a special issue of a journal, compendium, or conference proceedings during the 24 months preceding the submission of this proposal. If there are no collaborators or co-editors to report, state "None."

Graduate and Postdoctoral Advisors and Advisees: List the names and current organizational affiliations of your graduate advisor(s) and principal postdoctoral sponsor(s). Also, list the names and current organizational affiliations of your graduate students and postdoctoral associates during the past 5 years.

Personally Identifiable Information: Do not include sensitive personally identifiable information such as a Social Security Number, date of birth, or city of birth. Do not include information that a merit reviewer should not make use of.

APPENDIX 2: CURRENT AND PENDING SUPPORT

Provide a list of all current and pending support (both Federal and non-Federal) for the Principal Investigator(s) (PI) for ongoing projects and pending proposals. For each organization providing support, show the total award amount for the entire award period (including indirect costs) and the number of person-months per year to be devoted to the project by the PI. Do not list start-up funds provided to the PI by the employing academic institution. Provide the Current and Pending Support as an appendix to your project narrative. Concurrent submission of a proposal to other organizations for simultaneous consideration will not prejudice its review.

- This appendix will not count in the project narrative page limitation.

APPENDIX 3: BIBLIOGRAPHY & REFERENCES CITED

Provide a bibliography of any references cited in the Project Narrative. Each reference must include the names of all authors (in the same sequence in which they appear in the publication), the article and journal title, book title, volume number, page numbers, and year of publication. For research areas where there are routinely more than ten coauthors of archival publications, you may use an abbreviated style such as the Physical Review Letters (PRL) convention for citations (listing only the first author). Include only bibliographic citations. Applicants should be especially careful to follow scholarly practices in providing citations for source materials relied upon when preparing any section of the proposal. Provide the Bibliography and References Cited information as an appendix to your project narrative.

APPENDIX 4: FACILITIES & OTHER RESOURCES

This information is used to assess the capability of the organizational resources, including subawardee resources, available to perform the effort proposed. Identify the facilities to be used (Laboratory, Animal, Computer, Office, Clinical and Other). If appropriate, indicate their capacities, pertinent capabilities, relative proximity, and extent of availability to the project. Describe only those resources that are directly applicable to the proposed work. Describe other resources available to the project (e.g., machine shop, electronic shop) and the extent to which they would be available to the project. Please provide the Facility and Other Resource information as an appendix to your project narrative.

- Do not attach a separate file.
- This appendix will not count in the project narrative page limitation.

APPENDIX 5: EQUIPMENT

List equipment already available for this project and, if appropriate, identify location and pertinent capabilities. Provide the Equipment information as an appendix to your project narrative.

- Do not attach a separate file.
- This appendix will not count in the project narrative page limitation.

APPENDIX 6: OTHER ATTACHMENTS

Information not easily accessible to a reviewer may be included in this appendix, but do not use this appendix to circumvent the page limitations of the proposal. Reviewers are not required to consider information in this appendix, and reviewers may not have time to read extensive appendix materials with the same care they would use with the proposal proper.

- Do not attach a separate file.
- This appendix will not count in the project narrative page limitation.

3. Detailed Instructions for the Budget

Budgets are required for the entire project period. A budget form should be completed for each budget period of the award, and a cumulative budget form for the entire project period will be populated by PAMS. A detailed budget justification narrative should be included after the budget pages. The justification should cover labor, domestic travel, equipment, materials and supplies, and anything else that will be covered with project funds.

To edit a section on the budget, click the edit icon () for each section on the page. Remember to save all budget periods before moving on to the next section. You can save the budget periods by selecting "Save All Budget Periods" from the dropdown on the lower right corner of the PAMS budget entry screen and then clicking the "Go" button. You can also save any data entry page in PAMS using the blue diskette icon () in the floating toolbar on the bottom of the screen.

Section A. Senior/Key Person (Required)

For each Senior/Key Person, enter the appropriate information. List personnel, salary funds, and the number of months that person will be allocated to the project. Also include a written narrative in the budget justification that fully justifies the need for requested personnel.

Section B. Other Personnel

List personnel, salary funds, and the number of months that person will be allocated to the project. Also include a written narrative in the budget justification that fully justifies the need for requested personnel.

Section C. Equipment Description

For the purpose of this budget, equipment is designated as an item of property that has an acquisition cost of \$5,000 or more and an expected service life of more than one year. (Note that this designation applies for proposal budgeting only and differs from the DOE definition of capital equipment.) List each item of equipment separately and justify each in the budget justification section. Allowable items ordinarily will be limited to research equipment and apparatus not already available for the conduct of the work. General-purpose office equipment, such as a personal computer, is not eligible for support unless primarily or exclusively used in the actual conduct of scientific research.

Section D. Travel

In the budget justification, list each trip's destination, dates, estimated costs including transportation and subsistence, number of staff traveling, the purpose of the travel, and how it relates to the project. Indicate whether travel cost estimates are based upon quotes from travel agencies; upon past experience of similar number of trips to similar travel destinations; or something else (describe). To qualify for support, attendance at meetings or conferences must enhance the investigator's capability to perform the research, plan extensions of it, or disseminate its results.

Section E. Participant/Trainee Support Costs:

If applicable, submit training support costs. Educational projects that intend to support trainees (precollege, college, graduate and post graduate) must list each trainee cost that includes stipend levels and amounts, cost of tuition for each trainee, cost of any travel (provide the same information as needed under the regular travel category), and costs for any related training expenses. Participant costs are those costs associated with conferences, workshops, symposia or institutes and breakout items should indicate the number of participants, cost for each participant, purpose of the conference, dates and places of meetings and any related administrative expenses. In the budget justification, indicate whether trainee cost estimates are based upon past experience of support of similar number of trainees on similar projects; past experience of support of similar number of participants attending similar conferences/workshops/symposia; or something else (describe).

Section F. Other Direct Costs:

Enter Other Direct Costs information for each item listed.

• Materials and Supplies: Enter total funds requested for materials and supplies in the appropriate fields. In the budget justification, indicate general categories such as glassware, and chemicals, including an amount for each category (items not identified under "Equipment"). Categories less than \$1,000 are not required to be itemized. In the budget justification, indicate whether cost estimates are based upon past experience of purchase of similar or like items; quotes/catalog prices of similar or like items; or something else (describe).

- **Publication Costs:** Enter the total publication funds requested. The proposal budget may request funds for the costs of documenting, preparing, publishing or otherwise making available to others the findings and products of the work conducted under the award. In the budget justification, include supporting information. 2. Merit Review Criteria

Proposals will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, listed in descending order of importance.

- 1. Scientific and/or Technical Merit of the Project;
- 2. Appropriateness of the Proposed Method or Approach;
- 3. Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- 4. Reasonableness and Appropriateness of the Proposed Budget.

The evaluation process will include program policy factors such as the relevance of the proposed research to the terms of the DOE National Laboratory Announcement and the agency's programmatic needs. Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of a proposal constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

The following questions will be posed to reviewers for each of the review criterion listed above:

1. Scientific and/or Technical Merit of the Proposed Research

- What is the scientific or technical innovation of the proposed research?
- To what extent is the proposed research likely to achieve valuable results?
- To what extent might the results of the proposed research impact the direction, progress, and thinking in areas relevant to extreme-scale science research?
- How does the proposed research compare with other research in its field, both in terms of scientific and/or technical merit and originality?

2. Appropriateness of the Proposed Method or Approach

- To what extent are the research approaches logical and feasible?
- To what extent does the proposed research employ innovative concepts or methods?
- To what extent are the conceptual framework, methods, and analysis well justified, adequately developed, and likely to lead to scientifically valid conclusions?

• To what extent does the proposed research recognize significant potential problems and consider alternative strategies?

3. Competency of Applicant's Personnel and Adequacy of Proposed Resources

- To what extent does the project team have the requisite background and level of expertise to accomplish the proposed research?
- To what extent are the technical responsibilities of senior or key personnel clearly and adequately described?
- How well organized is the timeline for major research goals and objectives?
- To what extent does the proposed work take advantage of unique facilities and capabilities?

4. Reasonableness and Appropriateness of the Proposed Budget

- To what extent are the personnel staffing levels adequate for carrying out the proposed research?
- To what extent is the budget reasonable and appropriate for the scope of research?

B. REVIEW AND SELECTION PROCESS

1. Merit Review

Proposals that pass the initial review will be subjected to a formal merit review and will be evaluated based on the criteria above.

2. Selection

The Selection Official will consider the merit review recommendations, program policy factors, programmatic priorities, and the amount of funding available.

3. Discussions and Award

The Government may enter into discussions with a selected applicant for any reason deemed necessary. Failure to resolve satisfactorily the issues identified by the Government will preclude award to the applicant.

C. ANTICIPATED NOTICE OF SELECTION AND AWARD DATES
